2. **Motion by Ald. Kastner, seconded by Mr. Selin to approve the minutes of the July 23, 2015 meeting.**
Motion carried 6 - 0.
3. **Consider going into Closed Session pursuant to Wis. Stats., Sec. 19.85(1)(e) to:**
 - **Discuss redevelopment strategy for the TIF #4/#5/#6 areas as it may relate to the deliberation or negotiation of the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session.**

Motion by Mr. Carlson, seconded by Mr. Chowanec, to go into closed session per the above agenda.
On a roll call vote motion carried 6 - 0.

4. **Adjourn closed session and reconvene into Open Session.** Motion by Mr. Carlson, seconded by Ald. Kastner to adjourn the closed session and to reconvene into open session. On a roll call vote motion carried 6 - 0.
5. **Consider action/direction from the Closed Session.** Motion by Mr. Carlson, seconded by Mr. Chowanec to authorize the use of the annual CDA budgeted funds of up to \$30,000 for the purposes of completing a market analysis and basic site plan for the Loomis Crossing area (funds would be reimbursable as a TIF-eligible cost). Motion carried 5 – 1 with Ald. Kastner voting no.

6. **Staff to provide a general update on pending and/or anticipated development activities throughout the community.**

Mr. Sokol and Mr. Erickson gave an update on various development/redevelopment locations around the City; both active and not so active:

- ♦ 116th & Howard: Glen of Greenfield
- ♦ Denny's Restaurant
