2. An opening prayer was given by Pastor Joe McFadden.
3. Pledge of Allegiance
4. It was moved by Alderperson Bailey, seconded by Alderperson Saryan, to approve the May 2, 2017 Common Council minutes. Motion carried unanimously.

6. Aldermanic Reports

Alderperson Bailey said about 50-60 people attended Arbor Day. About 18 trees were planted, all to help deaden sound along Layton Avenue by Konkell Park. Shrubs will also be planted by the amphitheater. He attended a Tree Commission meeting and reported about 50 trees will be planted on the 43rd Street project from Layton Avenue south to Grange Avenue.

8. Citizen Commentary

Leon Adraktas, 9310 W. Waterford Ave., said he has problems with a busted fence bordering Clement Manor and he has had no luck contacting them. Last year they made an arrangement to have trees planted. Now he can't have his windows and door open in the mornings due to traffic to the adult daycare center. The water retaining area is full of weeds and looks terrible. Light from traffic shines into his home at night. He estimates his property value has decreased \$20,000 to \$30,000. Alderperson Kastner said the city would look into maintenance of the property.

Cheryl Kellerhals, 6088 W. Woodview Ct., said she appreciates attempts to fix noise issues related to House of Harley's outdoor entertainment; however, the music is still too loud and she asked if House of Harley could provide more specific and stricter guidelines to its bands as to how loudly

they play, and if soundproofing could be done behind the stage. She said she doesn't understand why something more can't be done.

Margaret Krog, 6188 W. Woodview Ct., said she is also unhappy with the sound level from House of Harley's outdoor bands. She said last year, the staff communicated by walkie talkies and were able to immediately get the bands' sound reduced when there were complaints. Maybe this could be done again. A recent event this year was too loud; changes to the stage did not sufficiently reduce the sound. She suggested House of Harley hold its special events elsewhere, such as at the Harley museum or State Fair Park. She said she and other residents will be meeting with Harley to see what solutions they can find.

Gregory Krog, 6188 W. Woodview Ct., said he agreed with previous comments regarding Harley. He said the new stage location is at a higher elevation, bordered by an empty field, and the sound level is still too loud. He's afraid they will have the same noise problem the rest of the summer. He feels the events should be elsewhere or indoors.
