THE FOLLOWING CONDITIONS, AS PER SEC 16:11(4), MUST BE MET FOR ISSUANCE OR RENEWAL OF A WELL OPERATION PERMIT:

- THE WELL AND PUMP INSTALLATION SHALL BE INSPECTED BY A LICENSED WELL CONTRACTOR. THE CONTRACTOR SHALL PROVIDE THIS OFFICE WITH COMPLETED NR 812 COMPLIANCE REPORT 3300-305 FORM STATING THAT THE WELL MEETS DNR STANDARDS FOR EXISTING WELLS, AS PER NR 812.42.
- THE WELL SYSTEM MAY NOT BE INTERCONNECTED WITH THE WATER UTILITY, NOR MAY IT DISCHARGE TO THE SEWER UTILITY. THE WELL (ON PROPERTIES SERVED BY MUNICIPAL WATER) MUST SOLELY BE USED TO SERVE ONE OUTSIDE HOSE FAUCET THAT IS EQUIPPED WITH APPROVED BACKFLOW PROTECTION. THIS MUST BE VERIFIED BY THE CITY OF GREENFIELD PLUMBING INSPECTOR PRIOR TO ISSUE OF PERMIT.
- PROVIDE THIS OFFICE WITH EVIDENCE OF A SAFE WATER TEST THAT HAS BEEN COMPLETED WITHIN THE PAST SIX MONTHS. A LIST OF CERTIFIED WATER TESTING LABS CAN BE OBTAINED AT THE DNR WEBSITE OR BY WAY OF CONTACTING THIS OFFICE.
- COMPLETED WELL OPERATION PERMIT FORM AND \$25 PERMIT FEE.

PERMIT FEE - \$25

Payment can be made by cash, check or credit or debit card. If paying by credit or debit card, a 2.5% processing fee will be added to the total permit fee.

****Please Note: Permit requires inspection. After a satisfactory final inspection a FIVE YEAR PERMIT is issued.****
