Summary of Incident

On Sunday, 02/23/20 at approximately 10:00 pm [REDACTED] [REDACTED], was at the residence 2054 South 15th Place, Milwaukee, WI. While at the home he got into an argument with a friend [REDACTED] knew [REDACTED] always carried a handgun with him. [REDACTED] said [REDACTED] was drunk and very upset about not being able to see his kids and about not wanting to go back to jail. [REDACTED] told him he needed to turn himself in to the police. At one point, [REDACTED] struck [REDACTED] several times in the face and stated, he was tired of life, that he was not going back to jail and "You know I'm going to die pretty soon so I don't give a fuck." He left the home with his dog, on Monday, 02/24/20 at approximately 12:45 am. A short time after he left, he called [REDACTED] from his cellphone, explaining he was near 23rd and Orchard and he lost his dog. As [REDACTED] was walking to the area to help him, she heard gun shots. She tried calling him back after but he didn't answer.

On Monday, 02/24/20 at approximately 1:00 am, [REDACTED] (obstructed police with name, [REDACTED]) was walking toward her friend's vehicle that was parked on the southeast corner of West Arrow Street and South Union Street in the city of Milwaukee. She saw a male subject wearing a black shirt arguing with one of her friends that was standing outside of the vehicle. As she approached, this subject pulled out a handgun and pushed it against her left eye. She later identified this male in a photo array as [REDACTED]. [REDACTED] struck [REDACTED] in the mouth with his pistol, then twice more in her forehead causing lacerations and requiring stitches. [REDACTED] demanded "Gimme what you got" attempting to rob [REDACTED] and the male passenger of property. [REDACTED] fled on foot when someone nearby yelled, "Hey" and distracted [REDACTED]. As she ran and hid near 1560 South Union Street, she heard gun shots from the area she just fled. The resident at 1560 South Union Street invited her into the home. After being in the home approximately five minutes she heard five to seven more shots appearing to come from outside that home.

The residence on the southeast corner of West Arrow Street and South Union Street, where the robbery occurred is 1541 South Union Street. At approximately 1:00 am, the resident, [REDACTED], heard gunshots outside his home. When he looked out his front window he saw a male in all black clothing holding a gun and firing several rounds to the south on South Union Street. The man was yelling at a residence mid block and walked toward that area. A few minutes later, [REDACTED] saw the same man [REDACTED] was walking backward on South Union toward West Arrow. He then turned around and started running north toward West Arrow Street. [REDACTED] noticed [REDACTED] was being chased by two Milwaukee police officers [REDACTED]. A short time after they ran out of view, he heard multiple gun shots.

At 1:03 am the City of Milwaukee ShotSpotter registered approximately seven rounds being fired near 1545 South Union Street, Milwaukee, WI. At 1:04 am Milwaukee squads were dispatched to that area. [REDACTED], resides at 1569 South Union Street and heard these shots outside his home. He looked outside and saw a male [REDACTED] on the side of the street pointing a gun at 1560 South Union Street and yell, "Don't be a pussy". A male on the upper balcony at 1560 then shot several times at [REDACTED]. At 1:06 am, the ShotSpotter registered these six shots being fired near 1574 South Union Street. After this second series of shots, [REDACTED] saw [REDACTED] point his gun again at 1560 and walk out into the middle of the street. He saw a Milwaukee police officer [REDACTED] arrive who told [REDACTED] to stop. They continued to walk northbound until out of sight.

A citizen's home surveillance camera at 1577 South Union Street recorded these details. [REDACTED] was seen confronting 1560 South Union Street appearing to point a gun at the home. Someone from the balcony of the home shot several times toward [REDACTED] who was standing across the street. After the shots,

[REDACTED] again pointed at the residence, what appeared to be a gun. He then walks out into the middle of the road. Video shows [REDACTED] arriving and making initial contact with [REDACTED] at that location. It also shows [REDACTED] arrival shortly after.

At 1:07 am [REDACTED] arrives in the area. At 1:08 am, a citizen caller reported two subjects with guns and one is dressed in all black. [REDACTED] noticed a male [REDACTED] matching the description walking north on South Union Street near 1560. [REDACTED] was walking swiftly with his hands stuffed in his front pockets. [REDACTED] ordered [REDACTED] to stop and to take his hands out of his pockets. [REDACTED] arrived on scene next, pulling into a driveway to the north of [REDACTED] and Officer [REDACTED] attempting to block [REDACTED]. He too ordered [REDACTED] to stop and show his hands. [REDACTED] was looking at [REDACTED] while walking backwards past his squad, refusing to obey commands. Officers heard [REDACTED] make statements similar to "shoot me" and also made a statement in spanish "Pues mata me" meaning "Go ahead and shoot me." [REDACTED] refused to obey officers and took off running northbound on South Union Street, then west on West Arrow Street. [REDACTED] noticed something bouncing around [REDACTED] midsection while he ran.

At 1:08 am, [REDACTED] arrives on scene on West Arrow Street. [REDACTED] observed a male subject wearing a dark hoodie running with his right hand in his front hoodie pocket. [REDACTED] was running westbound on West Arrow Street from South Union Street toward South Comstock Avenue. [REDACTED] was being chased by [REDACTED]. Officers gave verbal commands to "Stop" "Get your hands out of your pocket". [REDACTED] yelled, "I'm gonna blast you." [REDACTED] continued to run northbound in the 1400 block of South Comstock Avenue. Pursuing officers were positioned with [REDACTED] near the left sidewalk, [REDACTED] was near the middle/right side of the road and [REDACTED] was on the right sidewalk. While running down the middle of South Comstock Avenue, [REDACTED] turned toward officers and pointed a handgun. All three officers fired multiple rounds near the same time. [REDACTED] fired first (five rounds) followed by [REDACTED] (thirteen rounds) and [REDACTED] (three rounds). [REDACTED] fell to the ground in the middle of the street near 1452 South Comstock Avenue. As officers approached to take him into custody, a .380 semiautomatic handgun was located on the road at [REDACTED] right side. The slide was locked to the rear.

Two citizen witnesses were sitting in a parked vehicle at 1445 South Comstock Avenue. Both saw a man running toward them while being chased by police. The driver, ADRIAN DE JESUS MADRID LOPEZ, said the suspect [REDACTED] was right next to his driver's door when [REDACTED] reached into his front waistband, pulled out a gun and shot once at the police. The suspect then turned, started running again but then shot again at police.

On the above date and time I received a call from Detective Captain Chuck Fletcher advising there was an Officer involved shooting involving MPD. Due to our department being the lead agency for the M.A.I.T. team we were needed at the scene. I in turn responded to the command post.

Upon my arrival we were briefed on what occurred. Chief Morales of MPD also did a walk through of the scene with us to familiarize us with what occurred.

I was then assigned to assist and oversee the canvassing of the crime scene.

Members of the M.A.I.T. were standing by to assist. We started our canvass on South Comstock Ave.

At 4:20am I attempted contact at the following addresses, 1411 S Comstock, no answer, 1425 S Comstock, the door was answered by an adult Hispanic female. She said she spoke limited English. She said it was not a good time to talk and that everyone was sleeping. I told her I would attempt to come back with a Spanish speaking officer. She told me after 10:00 am. 1431 S Comstock Ave, was vacant, boarded up with padlock on front door. 1441 S Comstock Ave, the door was answered by an adult Hispanic male. He said he spoke limited English. He said around 1:00 am he heard 6 or 7 shots. He said he heard Cops screaming don't move. He said he waited for a short time before looking outside. He said he saw officers by the subject who had been shot. He said when he looked out he saw about 4 or 5 officers. He said he did not see anything before he heard the shots. I asked him for his name and he refused to provide it. I asked him about the video camera on the outside of his house and he told me it did not work. He said squirrels chewed through the wiring.

While I was speaking with this individual, Captain Christopher Marks with the West Allis Police Department came over to my location. He advised they were canvassing on the other side of the street and found a resident at 4128 South Comstock Ave who had video of the entire incident. I then went over to 4128 South Comstock Ave. and met with West Allis Detective Dan Ditorrice and resident [REDACTED] was able to show me the video which did appear to capture most of the incident.

After confirming there was video. I advised Captain Lindstrom and requested a video tech respond to our location to download the video. A short time later MPD Officer Teresa Cruz #1924 responded. She was able to download the video to my flash drive and it was turned over to me.

SUMMARY

On the above date and time, I was contacted by telephone by Detective Captain Chuck Fletcher advising there was an Officer involved shooting involving officers with the Milwaukee Police Department. Captain Fletcher advised that he needed me to respond to the scene as the Greenfield Police Department was assigned as the lead investigative agency as a part of the M.A.I.T. team.

Once I arrived at the command post, I met with Captain Fletcher and Captain Lindstrom who provided us with information regarding the incident and that I was assigned to assist and oversee the crime scene. Chief Morales also did a walk through of the scene with investigators. I was informed that shortly after 1:00AM, officers from District #2 of the Milwaukee Police Department was dispatched to the 1500 block of S. Union St for a ShotSpotter alert in which approximately seven gunshots were detected in the area. Several witnesses also contacted the Milwaukee Police Department reporting that there were subjects with guns in the area, one of them being a male wearing all black clothing. Information provided was there was a female that had been "pistol whipped" near W. Arrow St and S. Union St, sustaining injuries and was currently at the hospital. It was reported that this female arrived in the area in a blue vehicle with no plates. There were also currently Milwaukee Police Tactical officers at 1560 S. Union St clearing the residence after finding spent shell casings at that location. Upon the arrival of officers to the area, a subject matching the description was seen walking in that area and refused to comply with officers commands to stop and talk with them. This subject was walking west in the 1800 block of W. Arrow St and then went northeast on S. Comstock St where he pointed a firearm at the officers. At that time Milwaukee Police Officers returned fire, fatally wounding the suspect. At the time of the briefing, the suspect's identity was unknown.

The deceased was located in the middle of the street of S. Comstock Ave in front of 1445 S. Comstock Ave with portable crime scene walls surrounding. Located near the deceased was a Bersa .380 pistol bearing serial number #223524. The crime scene was maintained by officers from the Milwaukee Police Department, Greenfield Police Department, and by Trooper David Marquardt who is employed with the Wisconsin State Patrol. Trooper Marquardt completed FARO scans documenting the area and using total station. I was advised by Trooper Marquardt that a drone operator was also in route to the scene. Members of the Wisconsin State Crime Lab Response Team were also contacted to process the crime scene. The members were identified as LISA TREFFINGER, CHRIS JOHNSON, JAMES ARMSTRONG, PAMELA TAYLOR, ALYSSA MARES, and LEAHA LACKOWSKI. The

deceased was later identified using a Fast ID device that was brought to the scene. After I obtained the two index finger(right and left) fingerprints, I provided the device to Detective Lepper. The deceased was identified as [REDACTED]
[REDACTED].

On scene, I met [REDACTED], who stated that he had checked the deceased's pockets for any identification but had removed a cell phone from his pants pocket. This cell phone was placed into a paper bag and was then provided to Detective Wallander. At 6:13AM, after the Wisconsin State Crime Lab Response Team had documented the scene, I was informed that the Milwaukee County Medical Examiner could be contacted to come to the scene. I contacted the Milwaukee County Medical Examiner's Office and I was advised that Milwaukee County Medical Examiner's Forensic Investigator MICHAEL MARTIN would be responding to the scene. Once M.E. Forensic Investigator MARTIN arrived on scene, I provided him with the necessary information that he requested. I then led him to where the deceased was located. After documenting the crime scene and the deceased, M.E. Investigator MARTIN pronounced the time of death at 7:38AM. After the deceased's hands were covered at 8:35AM, [REDACTED] was turned over to the Medical Examiners transport staff. It should be noted that a pair of silver handcuffs were placed on [REDACTED] left wrist. The set of handcuffs had a white label that said [REDACTED] on it. I used my pen key to remove the handcuff from [REDACTED] wrist. The handcuffs were then packaged by me. Before the deceased was placed into a transport bag, I was provided with tag #214095 from MARTIN. The transport bag was then sealed by Forensic Investigator MARTIN. The body was then removed from the scene. I was provided with Milwaukee County Medical Examiner's Case Number 20-1215 by M.E. Investigator MARTIN. After the body was removed, evidence documented and recovered by the Wisconsin State Crime Lab, I was provided with all of the collected evidence by TREFFINGER. I was also provided with a handwritten Receipt of Physical Evidence form that was signed by TREFFINGER and I. These pieces of evidence was given Wisconsin State Crime Lab Case #R20-599. All evidence was later transported to the Greenfield Police Department where it was inventoried and placed into a property locker. The signed copy of the Receipt of Physical Evidence will be attached to the case file. The entered property was attached to the end of this report.

During the initial investigation, I was advised by Captain Fletcher that [REDACTED], had arrived on the scene and that I was needed to conduct and interview with her. This interview was conducted in Captain Fletcher's vehicle. [REDACTED] told me that she was talking to [REDACTED] and that he was intoxicated. [REDACTED] said that [REDACTED] and [REDACTED] were in an argument and that he later left the area. [REDACTED] said [REDACTED] called stating that he had lost his dog and that shortly after that they hear gun shots and that he was not answering his phone any longer. I asked if she knew of any place that he would get a firearm from. [REDACTED] stated he would have access to firearms and that he has been seen with several firearms. [REDACTED] stated [REDACTED] had been out of jail for approximately six

months and that he had been going from couch to couch as he was wanted by the police. [REDACTED] stated that he was wanted by the police for a pistol whipping and armed robbery that had occurred in December of 2019. [REDACTED] stated that she spoke to [REDACTED] on the phone who stated something to the effect of "Man nobody knows how I feel, I'm just going where I'm going, it don't matter" [REDACTED] told me that [REDACTED] was unable to see his children as there is a no contact order with the children's mother. [REDACTED] said she did not blame the police for what happened and said that he was not going to go without a fight. I asked if he had done anything like this in the past and she told me know but he had spoken about it and that she was prepared for something like this to happen. [REDACTED] stated she last spoke to [REDACTED] at approximately 12:30AM. [REDACTED] stated that she heard [REDACTED] arguing with someone. [REDACTED] told her something to the effect of "I'll have to call you back these niggas are lookin' at me funny" and then hung up the phone. [REDACTED] stated [REDACTED] did call her back a short time later stating the dog had been lost. I asked if [REDACTED] knew anyone in the area and she told me no. I asked if she knew of any drug use and she told me marijuana, cough medicine, and some times ecstasy. I asked [REDACTED] if [REDACTED] ever brandished a pistol at the house and she told me no. I asked her if there was anything else that she could remember she was to contact me. I thanked her for the information and I provided her with my business card.

On 02/25/2020, I responded to the Milwaukee County Medical Examiner's Office for the autopsy of [REDACTED]. The autopsy was performed by Dr. JESSICA S. LELINSKI. As the autopsy began, I could see that the decedent's hands were still bagged. There were multiple clothing items still on and under the decedent. These items were removed by Dr. LELINSKI and placed onto a table to dry. The clothing consisted of a black and red Jordan sweater with blood on it, a black short sleeve shirt with hood, a white t-shirt with blood on it, black Ecko brand sweat shorts, black Russell brand jogging pants, a pair of black socks, and a pair of black Nike Air tennis shoes. In the right black Nike Air shoe, it appears to be two bullet holes. One through the tongue of the shoe and the other through the right side of the shoe. In [REDACTED] outer right sweater pocket, Dr. LELINSKI located a small plastic baggie that contained a light brown powdered substance that based on my training and experience appeared to be heroin. This plastic baggie was turned over to me. All clothing items that were removed from [REDACTED] was brought back to the Greenfield Police Department where it was placed into the drying room and was inventoried into property. Once the clothing items were dry, they were packaged into separate paper bags, sealed with evidence tape, and was then placed into a property locker. At the beginning of the autopsy, Dr. LELINSKI removed all of the medical equipment that was from the attempted life saving measures and disposed of them. Dr. LELINSKI found abrasions and lacerations to the left side of [REDACTED] face above his left eye brow. There were also abrasions to [REDACTED] elbows and knees. Dr. LELINSKI located a penetrating gunshot wound to [REDACTED] right shoulder and I was advised that they he located a bullet near [REDACTED] chin. This bullet was later recovered and

turned over to me. Dr. LELINSKI also documented a perforating gunshot wound to [REDACTED] right foot. [REDACTED] foot had an entrance wound and an exit wound. Dr. LELINSKI ruled this as a homicide. I was provided with a DNA card, nail clippings, and hair sample which was signed for as well as [REDACTED] clothes. A copy of the signed property sheet will be attached to the case file.

I removed Greenfield Police Department Property #20-646-9 labeled "Unknown white substance in tied plastic baggie removed from [REDACTED] from a property locker in order to weigh and test the substance, Greenfield Police Department Property #20-632-32 labeled "1 plastic baggie from right side of body decedent", Greenfield Police Department Property #20-632-30 labeled "Contents of left jacket pocket of decedent 3 baggies +1 foil packet of cigarellos". I used an electronic scale to weigh each item. The baggie of green leafy substance that was removed from #20-632-30 weighed 2.53 grams. I used a Duquenois Levine Reagent NARK II Test pouch. It should be noted that I am trained and certified in the use of this field testing drug pouch. The green leafy substance tested positive for THC. This was repackaged and inventoried and provided Greenfield Police Department Property Number 20-670-3. The baggie of marijuana roaches weighed 1.7 grams. This item was repackaged and given Greenfield Police Department Property #20-670-1. The off white rock like substance removed from #20-632-30 weighed 2.38 grams. This substance was tested using the Scott Reagent NARK II Test Pouch. This substance tested positive for cocaine. This was repackaged and assigned Greenfield Police Department Property #20-670-2. The small plastic baggie assigned Greenfield Police Department Property Number #20-632-32 weighed 1.14 grams. The small plastic baggie assigned Greenfield Police Department Property #20-646-9 weighed .62 grams. I used a Fentanyl Reagent NARK II Test Pouch which showed a positive for Heroin for each baggie. I then used a Mecke's Modified NARK II test pouch which each baggie tested positive for heroin. The white grape cigarillo package was re-inventoried and assigned Greenfield Police Department Property #20-670-4. All items were packaged separately and placed into a property locker.

On 02/27/2020 at 9:13AM, I responded to the Wisconsin State Crime Lab to submit evidence for this case. Once on scene, I met with Wisconsin State Crime Lab employee, CAROL J. WINKE. I provided her all of the officer's shell casings collected from the crime scene (Greenfield Police Department Property #'s 20-632-5 through 20-632-22 and 20-632-24 through 20-632-26), each officer's duty pistol (Greenfield Police Department Property #'s 20-626-1, 20-625-1, and 20-627-1), the Bersa .380 ACP pistol recovered from the crime scene (Greenfield Police Department Property #20-632-2), one sealed envelope containing dried blood standard recovered from [REDACTED] (Greenfield Police Department Property #20-646-3) and one heat sealed plastic bag containing fired bullet recovered from [REDACTED] (Greenfield Police Department Property #20-646-2). I was provided with a Receipt of Physical Evidence that was signed by WINKE. This receipt of physical evidence form was attached to the case file. The

submitted evidence was provided with the same Wisconsin State Crime Lab Case #R20-599.

On 02/28/2020, I contacted the Milwaukee County Medical Examiner's Office regarding a Preliminary Autopsy Report and this was later received via email. The Preliminary Autopsy report will be attached to the case file. Once the final autopsy report is available, it will be attached to the complaint.

[REDACTED] was the second officer whom had been involved, and Detective Stucker advised he would conduct his interview. The last officer involved was [REDACTED]. On the above date and time, I was contacted off duty by Greenfield Police Detective Captain Chuck Fletcher informing me of a Milwaukee Area Investigative Team (M.A.I.T.) call out regarding a Milwaukee Police Department officer involved shooting. I was informed that this incident occurred near the intersection of W. Arrow St. and S. Comstock St and to meet in that area at the command post.

I arrived at the scene at approximately 3:25am and met with other M.A.I.T. investigators for a briefing of the incident. I was informed that shortly after 1:00am, the Milwaukee Police Department District 2 was dispatched to the 1500 block of S. Union St for a ShotSpotter alert in which approximately 7 gunshots were detected in this area. Several witnesses also contacted the Milwaukee Police Department reporting that there were subjects with guns in the area, one of them being a male wearing all black clothing. Information provided was there was a female that had been "pistol whipped" near W. Arrow St and S. Union St, sustaining injuries and currently at the hospital. It was reported that this female arrived in the area in a blue vehicle with no plates. There were also currently Milwaukee Police Tactical officers at 1560 S. Union St clearing the residence after finding spent casings at that location.

Upon the arrival of officers to the area, a subject matching the description was seen walking in that area and refused to comply with officers commands to stop and talk with them. This subject was walking west in the 1800 block of W. Arrow St and then went northeast on S. Comstock St where he pointed a firearm at the officers. At that time Milwaukee Police Officers returned fire, fatally wounding the suspect. At the time of the briefing, the suspect's identity was unknown.

Greenfield Police Department was the lead for the M.A.I.T investigation and members of our agency were provided an initial walk through of the scene. The scene had been secured already by Milwaukee Police and cordoned off with police tape. The deceased male suspect was lying in the street in front of 1452 S. Comstock St. I observed a dark colored semi automatic handgun on the street next to the suspect.

South Comstock St is one street to the west of and runs parallel with S. Union St. It was explained that the suspect was being ordered to stop by Milwaukee Police Officers from the area of W. Union St where the first ShotSpotter reports of gunfire were reported and he continued to walk and then run on foot to the west on W. Arrow St and then north on S. Comstock St. where he produced and pointed a firearm towards officers.

I was assigned along with Detective John Lucas to manage the crime scenes. Detective Lucas met with Crime Lab personnel as they arrived on scene. I spoke with the second independent citizen witness, who stated that he understood and spoke English. It should be noted that both of these citizen witnesses were in an automobile together when they witnessed the officer involved shooting.

I then learned that there were two citizen witnesses who lived in the area and had rounds shot into their residence, where they live with their two young children. I asked Greendale Detective Julie Barth to interview these two citizen witnesses and Detective Barth subsequently did so.

I was informed that there were six additional citizen witnesses who had been inside the house at 1560 S. Union Street, when this shooting had occurred. It had been further explained that two male subjects from inside the residence at 1560 South Union Street had been shooting at the suspect in this incident, [REDACTED], who was outside of this residence.

I asked her if her brother used any street drugs and she said he did not. █████ said her brother did not want to live without his kids. I asked █████ if she was aware of her brother owning any firearms and she stated she was not. I asked her if her brother was feuding with anyone and she said he was not feuding with anyone, other than his "baby mama". I asked █████ if her brother was a gang member. Incident #77586 indicates that seven rounds were fired on 02/24/20 at 01:03:04. Incident #77587 indicates that six rounds were fired at 1574 South Union Street on 02/24/20 at 01:06:39. Incident #77588 indicates that sixteen rounds were fired at 2100 West Orchard Street on 02/24/20 at 01:09:50.

The report states that during analysis, it was noted that the incident location that was automatically calculated by ShotSpotter for incident #77588 was incorrect by approximately 200 meters to the northwest; this was due to several sensors not detecting the first few shots of the incident, causing a pulse mismatch. After analysis, the location for incident #77588 was corrected to "in front of 1452 Comstock Avenue". It should be noted this is the area where officers engaged suspect [REDACTED].

After review of the analysis, it was determined that the discharge times and locations of 32 rounds fired were calculated and these locations, including latitude and longitude and times that the rounds were discharged, will be included in this report.

On the above day and date, I received information from Captain Eric Lindstrom that Milwaukee Police Officer Dale Anders from their Fugitive Apprehension Unit had been previously assigned to track down the decedent, [REDACTED] had been in contact with [REDACTED].

It had been relayed to Captain Lindstrom that Officer Anders reported [REDACTED] had called 911 on [REDACTED] multiple times trying to get him arrested on his warrant. [REDACTED] said she had informed officers that [REDACTED] was associated with the back house at [REDACTED] and stated he was going to get the cops to kill him. Officer Anders had stated that [REDACTED] would always call or text and would never meet in person because she was afraid.

I attempted to call [REDACTED] multiple times at [REDACTED] however, there was a voicemail with a male subject's voice. After a third attempt, I was able to make contact with a subject who stated a [REDACTED] was not associated with this phone number. I conducted a KGIS search and found information for [REDACTED] with a different telephone number. I attempted to contact her; however, that phone number was out of service.

I was then able to make contact with a relative of [REDACTED] and a short time later, I received a call from a female claiming to be [REDACTED]. After speaking with her, she agreed to meet with me on Tuesday, 03/10/20, at the McDonalds in the area of 12400 West Capitol Drive, City of Wauwatosa, County of Milwaukee. [REDACTED] stated she did not feel comfortable meeting at the police department.

On Tuesday, 03/10/20, I met with [REDACTED] inside of McDonalds. She explained to me that she is married to her wife and [REDACTED].

[REDACTED] said she also lives there with her mother-in-law. She explained that she and her wife are currently in the process of adopting a one year old boy. [REDACTED] told me that because of who [REDACTED] hangs out with and the activities that he is involved in, she was afraid of him. She said they did not want anything to happen to their house, especially since they were trying to adopt this child.

[REDACTED] told me that prior to this officer involved shooting, she had been aware of the fact that [REDACTED] had warrants issued for his arrest including other incidents, including one possibly being a shooting. [REDACTED] stated this was not right and if a person is man enough to do the crime, the person has to be man enough to stand up and do the time. [REDACTED] who again stated she was extremely fearful for her safety and the safety of her wife and soon-to-be adopted son, said she always gave information anonymously and called in tips to the police department as to where they could locate [REDACTED].

[REDACTED] told me as far as she knew, the police had not located [REDACTED] and they were continually looking for him since this past November. She said that [REDACTED] would associate with people [REDACTED] however, once in a while he would speak to her mother-in-law and say hi to her. [REDACTED] said her mother-in-law was extremely careful about who she allowed to be at the house and that she did not want [REDACTED] at the house. I asked her what crime she was specifically referring to. She said she was not sure, but in her opinion, it seemed like he had an internal fight going on.

I asked [REDACTED] if she had ever specifically heard [REDACTED] say he was going to try to get the police to shoot him in what is commonly referred to as "suicide by cop", and she said she did not specifically hear him say that. [REDACTED] again did say that [REDACTED] had made statements to her mother-in-law on the porch that night that he was not going back to jail under any circumstances, no matter what. [REDACTED] told me upon hearing that statement, she believed [REDACTED] would definitely do anything possible not to go back to jail.

I again asked [REDACTED] if she ever had any type of personal relationship with [REDACTED] and she stated she did not. She said she had met him for "like thirty seconds". She said she would give tips to the police as to where [REDACTED] had been, due to his warrants. [REDACTED] said she even called the police and said that [REDACTED] would be going to an address in Waukesha.

I asked her who was in Waukesha that [REDACTED] knew and she said it was another person whom she only knows as [REDACTED]. She said [REDACTED] just got out of prison for dealing and that [REDACTED] hung out together. I asked her what [REDACTED] real name was and she stated she did not know it, but that she was confident the Waukesha Police Department would know who [REDACTED] was. [REDACTED] told me she thought [REDACTED] was a Latin King gang member, as the Latin Kings had a large presence in that area where he lives.

On the above date and time, I responded to 2054 S. 15th Place, in the City of Milwaukee in order to speak to [REDACTED]. It should be noted that [REDACTED] responded to the initial scene on 02/24/2020. I was also able to locate a Facebook profile matching with photos matching [REDACTED]. The Facebook profile name is [REDACTED]. In a post that was created on 02/26/2020 at 6:40PM, it shows a picture of [REDACTED] and [REDACTED] together. In [REDACTED] left hand is a grey pistol that closely resembles the pistol that was located at the crime scene. A screen capture of the photo and the Facebook post will be attached to the case file.

Once I arrived on scene, I was able to speak to [REDACTED] in my squad car. I asked [REDACTED] how she was handling this situation and she told me "rough". [REDACTED] told me that she thought the police had over done it as [REDACTED] had no bullets in his gun as an officer had informed her of this fact. [REDACTED] told me that she knew that [REDACTED] was on the run but was not sure what he was on the run for. [REDACTED] told me that [REDACTED] did not have a primary residence as he was staying place to place. [REDACTED] told me that [REDACTED] was going through a lot and wanted to see his kids and that it would make him crazy that he could not see his children. [REDACTED] said [REDACTED] was scared to go back to jail as he said he was going to go for a lot of years and that his children were going to grow up not knowing their father. [REDACTED] originally stated that she was family and I asked how she was related to [REDACTED]. [REDACTED] stated that she was not blood related and that they were friends as they had grown up with each other. I asked how she knew [REDACTED] and she told me that [REDACTED] is her mother's best friend.

[REDACTED] told me that she was with [REDACTED] on 02/23/2020 as [REDACTED] was going through a lot. [REDACTED] stated [REDACTED] was outside and had been drinking Hennessy. [REDACTED] stated her mother as well as her were urging [REDACTED] to turn himself in. [REDACTED] stated this conversation happened around 10:00PM. [REDACTED] said [REDACTED] was walking around with his dog when she was contacted by [REDACTED] stating that he had lost his dog. [REDACTED] stated this telephone call took place at 12:46AM. During the interview with [REDACTED] I was informed that [REDACTED] and [REDACTED] had an argument and that [REDACTED] had pushed her into the door frame and then left the property. [REDACTED] told me when [REDACTED] was drunk he had punched [REDACTED] approximately four times in the face. [REDACTED] said that she already understood that [REDACTED], "didn't give a fuck about his life". like this in the past and she told me no. [REDACTED] continued to say [REDACTED] would go crazy if he could not see his kids. I asked [REDACTED] if she knew the reason why [REDACTED] could not see his children and she told me she was not sure. I asked [REDACTED] if [REDACTED] used drugs and she told me that he would only smoke marijuana.

[REDACTED] said after she was stuck in the face [REDACTED] left with his dog. [REDACTED] said after [REDACTED] had called her asking for help looking for the dog she could here [REDACTED] speaking Spanish asking someone in the back ground if they had seen a dog. [REDACTED] said he did not here any arguments on the other end of the phone. [REDACTED] told me that the phone had hung up and that she called him back right away. [REDACTED] told me that [REDACTED] had said that he was near 23rd and Orchard. [REDACTED] stated as she was walking to the area she heard gunshots. [REDACTED] stated that she was near 21st and Maple when this occurred. [REDACTED] told me that she tried to call [REDACTED] after the gunshots and she was not able to make contact with him.

I asked [REDACTED] if she saw him with a gun at anytime and she said no. I showed a photo of the Bersa .380 firearm recovered from the scene and I asked her if she had ever seen [REDACTED] with this firearm and she told me no. I then showed her the photo mentioned earlier that was recovered from Facebook and she told me that she did see him with a gun. [REDACTED] told me that the photo was taken two weeks before the incident at a house [REDACTED] but she did not know the address. [REDACTED] stated that they were just taking photos and [REDACTED] said "lets take pictures for our memories" and [REDACTED] said that [REDACTED] had already told people that they weren't going to see him anymore if he got caught. [REDACTED] stated as she was taking photos, [REDACTED] pulled out a gun from his pocket. [REDACTED] asked to see the photo that I had shown her earlier and she told me that she thinks it was the same gun that he had two weeks earlier. I asked [REDACTED] if she was worried at all for her safety when he produced the gun and she told me that [REDACTED] would put the gun on safe and that he did not have any bullets for the gun. She told me [REDACTED] would carry around a gun wherever he went. [REDACTED] said that he did not have money for bullets. I asked her how she knew it was unloaded and she told me that [REDACTED] had shown her by taking out the magazine and racking the slide back. After taking [REDACTED] statement, I provided her with my business card with the case number on the back and told her to contact me if she remembered anything else. On the above day and date, I reviewed the body camera which had been worn by [REDACTED]. It should be noted that the timestamps on the body camera video did not appear to be accurate with the time of the call. The date did show the correct date of 02/24/20; however, the time at the video's start was 07:08:27.

The video starts with [REDACTED] inside of his squad, which is moving slowly southbound on what appears to be South Union Street. [REDACTED] front driver's side window begins to lower and [REDACTED] exits his squad. He turns towards the sidewalk and a subject is observed walking northbound on the east side of the street on the sidewalk. The subject is wearing all dark clothing. [REDACTED] appears to be trying to hail the subject as he stretches out his hand towards the subject and his mouth is observed moving as if he is talking to the subject. At this point, the audio on the video had not yet activated. The subject continued walking. As soon as the audio activates, [REDACTED] is heard stating in a loud and commanding voice, "Sir, can you please stop and take your hands out of your pocket for me right now? I'm asking you to stop right now, don't move! Sir! Stop! Do not move right now!"

As he is saying this, the subject turns around, walking away from the officer and walking backwards. It does sound as if the subject is saying something, but I could not make out what he says. The subject's left arm is seen raised away from his body, but his right arm is not visible and appears to be along his right side. A second marked police squad car pulls up and partially into a driveway ahead of the suspect, in what appears to be an attempt to stop his path of travel away from [REDACTED]. [REDACTED] yells, "Grab him!" [REDACTED] then begins running, at which time due to the jostling of the video the suspect is not seen. While he is running, [REDACTED] is yelling in a commanding voice for the suspect to stop and take his hands out of his pockets. When the camera settles down, the suspect is still on the sidewalk, but past the squad car that had pulled partially into the driveway ahead of him. The suspect is walking away from [REDACTED], but walking backwards to face [REDACTED].

At this point, [REDACTED] firearm is out and is pointed at the suspect. As the suspect is walking backwards, still facing [REDACTED], his right hand is conspicuously at his right side and his hand is initially not visible. His left hand is slightly away from his body. At one point, something near the suspect's right hand is observed as it appears lighter in

color than his pants and sleeve, but it is still at his right side. At this point it is unknown if he has anything in his hand or if he is keeping his right hand directly against his side. Someone turns a light on the suspect, at which time he turns and begins running away. [REDACTED] continues shouting orders at the suspect to take his hands out of his pockets. The suspect continues running westbound on the north side of West Arrow Street, on the sidewalk. As the suspect gets to South Comstock Avenue, he turns right onto northbound South Comstock Avenue and appears to be running in the middle of the street. An officer is briefly observed running almost parallel to [REDACTED] and the second officer is to the west of [REDACTED]. [REDACTED] begins running on the sidewalk on the east side of the street.

At approximately 1:19 into the video, at least nine gunshots are heard but due to [REDACTED] running, it is not known who is firing. [REDACTED] does not appear to be firing initially. At approximately 1:22 into the video, [REDACTED] fires one shot and he appears to be on the property of a residence on the east side of the street.

At approximately 1:23 into the video, [REDACTED] fired two more shots and when he does so, the suspect is observed in the roadway ahead of him. The suspect falls to the ground.

A subject is seen across the street, which turns out to be an officer, [REDACTED] based on other videos I have observed. [REDACTED] was on the sidewalk on the west side of the street, near a white sedan, which had its headlights on. [REDACTED] yells to [REDACTED] and asks him if he is okay. It appears as if [REDACTED] replies that he is, and a third officer begins making his way up the street, also directing his attention to the suspect, who is observed laying on the ground in the roadway. [REDACTED] gets on the radio and advises that shots have been fired and requests medical and a supervisor. He then provides the location of 1452 South Comstock Avenue.

[REDACTED] makes contact with the third officer, [REDACTED], who acts as a cover officer while [REDACTED] slowly approaches the suspect, who is laying facedown in the roadway. As he gets closer to the suspect, he says, "Gun!" Blood is observed from underneath the suspect. A small pistol is briefly observed next to the suspect, on his right side, just below the suspect's elbow. [REDACTED] and other officers begin issuing the suspect commands not to move or go for the gun. [REDACTED] then places the suspect in handcuffs at approximately 2:50. Blood is seen coming from an unknown area near the suspect's neck and right shoulder, although it is unclear where the blood is actually coming from based on the camera view.

[REDACTED] then rolls the suspect over and he begins checking for a pulse, which he states he does not feel. He does observe that the suspect is

breathing, although the camera does not show this. The suspect appears to be a white male and does move slightly at 3:44 into the video. [REDACTED] tries communicating with the subject, but there is no response.

When the suspect is rolled over, there does appear to be blood coming from the suspect's face. [REDACTED] comments that the suspect may have been hit somewhere near the top of his shoulder. [REDACTED] requests a knife so that he can cut open the suspect's clothing in order to better address where he is wounded. At approximately 4:41 into the video, officers verbally note that the suspect is breathing and the suspect does appear to move again on his own, with his head and mouth moving. They then roll him into the recovery position. They note a gunshot wound to the back and also comment that there is a lot of blood on the back of his head, which they believed might be another gunshot wound.

At approximately 5:30 into the video, a MPD officer who was not one of the three initial officers on scene, comes up to [REDACTED] and has him step away, as other officers are attending to the suspect. This other MPD then walks [REDACTED] away from the scene. The remainder of the video is [REDACTED] walking away from the scene. At one point, he does mention having dropped his taser. The video stops at 8:44.

The first report states that the Bersa model 83, 380 semi automatic pistol was fired and entered into the National Integrated Ballistic Information Network (NIBIN) Database and no investigative leads were established at this time.

The second crime lab report states five fired casings found on scene were related to [REDACTED] duty pistol, three fired casings found on scene were related to [REDACTED] duty pistol, and thirteen fired casings were related to [REDACTED] duty pistol. The fired jacketed hollow point bullet recovered from [REDACTED] revealed it is a 9mm caliber and was fired through a firearm barrel rifled with six lands and grooves with a right hand twist. On the above day and date, I was asked to review the body camera videos for the involved officers in this incident. The following is a summary of [REDACTED] body camera. Let it be known that the timestamp on the video did not appear to be accurate, although the date stamp was accurate and showed 02/24/20. The video began with a time stamp of 07:08:48.

The video starts inside of a squad car. [REDACTED] is driving and he turns to go southbound on South Union Street. A subject is seen walking northbound on the east side of the street, on the sidewalk, almost immediately. The subject is dressed in all dark clothing and is walking backwards on the sidewalk facing away from [REDACTED]. [REDACTED] pulled the squad partially up a driveway and appears to be attempting to block the subject's path of travel. The suspect is seen then running past the front of his squad. The subject is a male, again dressed in dark clothing, and looks directly at the squad car as he passed. [REDACTED] appears to be only a few feet from him, as the suspect passes and begins walking backwards after passing [REDACTED]. [REDACTED] has his firearm out and pointed at the suspect. The suspect keeps his right hand close to his right hip. It does appear as if the suspect does have something in his right hand, possibly the firearm which is later observed on video. This is based off of a few of the frames in which there does appear to be the shape of a small pistol in his right hand, as well as the color, which does not match with the suspect's skintone, or his other hand which is also observed in certain frames. [REDACTED] activates his pistol light and directs it towards the subject and something in the subject's right hand is again observed. The suspect keeps his right hand close to his side, while his other hand comes out and appears empty.

It is at this point that [REDACTED] audio kicks in and the suspect starts running. Another officer is observed chasing after the suspect, who begins running across the street to go westbound on West Arrow Street. This officer appears to be [REDACTED]. An officer is heard yelling "Stop!" to the suspect. An officer is also heard yelling for someone to, "Call it out!" [REDACTED] is heard yelling, "Don't move!" As [REDACTED] is running westbound on the north side of West Arrow Avenue, the suspect is no longer seen due to the distance, the shaking of the camera and the darkness. A vehicle does appear to be stopped with its headlights activated near the intersection of South Comstock Avenue. It is at this point that once [REDACTED] passes that location, a second subject is seen running whom is believed to be [REDACTED]. [REDACTED] He is also in foot pursuit of the suspect. northbound on the sidewalk on the east side of the street. [REDACTED] makes his way to the east side of the street towards a vehicle with its headlights activated, parked on the west side of the street facing southbound. The shape of what appears to be the suspect is briefly seen in some frames in the middle of the street.

[REDACTED] has his gun light activated and begins firing. [REDACTED] fired thirteen times. He began firing just after another gunshot was heard. Other gunshots are heard firing during some of the time in which [REDACTED] is firing. His first shot appears to be approximately 59 seconds into the video and he stops firing at approximately 1:03 into the video. [REDACTED] begins yelling for the suspect to stay on the ground and not to move. He begins asking other officers who are forward of his position if they are alright. [REDACTED] begins yelling for [REDACTED] to check the vehicle which is behind him. This is the vehicle parked on the west side of the street with its lights on, as [REDACTED] begins advancing down the street, the suspect is observed laying in the street.

[REDACTED] repeatedly yells for the subject not to move. [REDACTED] keeps his flashlight on the car with the subjects in it while keeping his gun pointed towards the suspect. He begins telling the suspect to put his arms out like an airplane. He and [REDACTED] coordinate to provide contact and cover on the suspect. [REDACTED] orders the suspect again to put his arms out like an airplane. The suspect does not move at all while being ordered to do so. It should be noted that a pistol is observed along the suspect's right side, just below his elbow, on the street. [REDACTED] comments that the suspect moved and [REDACTED] begins ordering the suspect not to move. [REDACTED] orders the suspect not to move for the gun. [REDACTED] is able to use his foot to slide the pistol away from the suspect's body. [REDACTED] provides cover while [REDACTED] takes the suspect into custody. It should be noted that there is blood from somewhere below the suspect's face, and he is laying on his stomach facedown. There also appears to be blood coming from somewhere near his upper chest. [REDACTED] completes putting the suspect in handcuffs and he rolls him over onto the suspect's side and back. [REDACTED] begins checking for a pulse and does make a comment that the suspect is breathing.

[REDACTED] puts his pistol away and helps illuminate the suspect for [REDACTED]. When the suspect is rolled over, he is observed with blood on his face and also some from the area of his shoulder. The suspect is observed moving his head and mouth but does not appear to be responding in any other way. At this point, other officers arrive and the initial officers ask for a pair of gloves. [REDACTED] is able to remove some of the suspect's shirt and sweatshirt and they are able to locate a gunshot wound on his upper back. The suspect is placed on his side. Someone is heard updating dispatch over the radio as to the things [REDACTED] are commenting about reference the suspect's injuries.

The pistol is observed during portions of the video in an area a few feet from the suspect on the ground. [REDACTED] advises around 6:09 into the video that the subject has a pulse. At approximately 6:37 into the video, the suspect's pistol is observed under the light of a flashlight briefly and does appear out of battery, with the slide locked back. Other officers begin assisting [REDACTED] with the suspect. [REDACTED] continues to check the suspect's pulse and occasionally does chest rubs while another officer applies some type of bandage to the suspect's head. An officer then comes up to [REDACTED] and begins leading him away from the scene, and the video is turned off a few seconds later at 9:56.

I was asked to review the body cameras of the three officers whom had been involved in this incident. The following is a review of [REDACTED] body camera footage. This is a summary only; please see the video for full details. One note I will make about the body camera video is that the date appeared correct on the video, but the time did not appear to be accurate.

The video started inside of a squad car as [REDACTED] was responding to the area. At thirty seconds into the video, the audio activated. [REDACTED] was stopped in the roadway and appeared to be talking to someone from his squad car. He appears to be talking to a woman and is just ending the conversation as the audio begins. He appears to make contact with that woman on South Comstock Avenue. As he is slowly driving down the street, he stops at West Arrow Street. A radio broadcast comes in from dispatch reference a ShotSpotter call at 1545 Union. There is also a report of two suspects outside with guns. A description is given out of a male wearing all black with a gun. [REDACTED] makes the turn to go eastbound on West Arrow Street and stops his vehicle in the roadway shortly after making the turn onto West Arrow Street. As [REDACTED] exits his vehicle, he immediately begins shouting to a male suspect who is dressed in all black and is running past his squad on the north side of West Arrow Street. The suspect is running westbound on the sidewalk. [REDACTED] takes out his firearm and points it at the suspect. [REDACTED] yells for the suspect to get on the ground. The suspect continues running past him, at which time [REDACTED] begins pursuing him on foot. As he is yelling at the suspect, he activates what appears to be his pistol light on the suspect, as the suspect runs past him. The suspect continues running.

[REDACTED] is observed turning to go northbound onto West Comstock Avenue. At this point, it is difficult to see the suspect due to the jostling of the camera, due to [REDACTED] running. As he turns onto West Comstock Avenue, there is a vehicle parked on the west side of the street facing southbound with its headlights on. [REDACTED] yells that the suspect "has something in his hand." A second later, [REDACTED] is seen with his pistol pointed in the direction of the suspect who does come into view in front of him and [REDACTED] begins firing.

He fires five shots in rapid succession at the suspect. Other gunshots are heard just after [REDACTED] begins firing and continue to be heard in the background after [REDACTED] stops firing. [REDACTED] begins making his way past the vehicle with its headlights on, on the sidewalk, on the west side of the street. [REDACTED] is heard yelling for the people in the car not to

move. [REDACTED] camera catches the suspect laying in the roadway briefly and he illuminates the suspect with his light. It appears that [REDACTED] diverts [REDACTED] attention to the people inside of the vehicle he just passed. The vehicle can be heard running. [REDACTED] camera captures the rear passenger side window rolling down and someone inside who is putting up his hands. Another subject exits the front driver's side door with his hands up and gets on the ground, [REDACTED] commands. A second subject exits the vehicle.

The two subjects appear to be younger Hispanic males, one wearing a black Adidas sweatshirt and the other wearing a lighter grey sweatshirt. He directs both subjects to the ground outside of the vehicle. His attention is focused on the two subjects and other officers can be heard yelling in the background for the suspect not to move and not to go for the gun. An officer comes over and assists [REDACTED] in taking the two subjects from the vehicle into custody and they are placed in handcuffs. He then explains to the backup officer who arrives to help him that it appeared as if the suspect may have been running towards the vehicle the two subjects were in.

[REDACTED] stands by with the two subjects who are on the ground in handcuffs. Another officer comes over to help check the two subjects in custody for injuries and [REDACTED] begins to check one of the subjects by patting him down. The other officer who came to backup [REDACTED] can be heard talking to one of the subjects, asking if they knew who the suspect in the street who was shot. The subject denies knowing who that was.

[REDACTED] walks one of the subjects over to a squad car and turns him over to another officer. At this time he then meets with another officer and [REDACTED] and the two appear to begin to check each other for any injury. The body camera is then turned off at 9 minutes and 43 seconds.

[REDACTED] She confirmed she lives at [REDACTED] [REDACTED] and that she had called 911 regarding this shooting. When I spoke with her, she advised she had already spoken to Milwaukee officers.

[REDACTED] said she had been making a bottle the morning of the incident. Her attention was drawn to the events outside in front of her house when she heard gunshots. She said the gunshots sounded as if they were coming from the front of the house. She looked out the window and observed a man and a woman in the front near her garbage cans. She said the woman had a rag she was holding to her face. [REDACTED] assumed she had been assaulted in some way, by the way she was holding the rag to her face. She said the male with her had a gun in his hand.

[REDACTED] recalled seeing a third person who was standing in the street. He was a Hispanic male wearing a black hoodie and black pants. She described him as skinny, possibly around 5'5" tall. She said the third subject in the middle of the street had a gun in his hand and was pointing it directly at the neighbor's house next door. She said she heard approximately three more gunshots. Initially, she said she saw this person firing his gun, but then stated that her brother was the one who had actually seen this. She said she assumed he was the one shooting, because he was pointing his gun.

She said the subject in the street began walking towards Mitchell Street and was on the phone. When a squad car pulled up near this subject, she observed this subject being chased by three police officers. She advised they were chasing him towards West Arrow Street.

I asked [REDACTED] if she would have her brother contact me when he came home from work, which she said she would. She did advise that her brother lived with her. I have since called multiple times, but [REDACTED] brother has not returned my call.

On the above day and date, I received a Confidential Report of Laboratory Findings from the Wisconsin State Crime Lab regarding evidence examined by the DNA Analysis Unit of the Wisconsin State Crime Lab. The Confidential Report of Laboratory Findings examined a Bersa handgun that was found near the deceased and a dried bloodstain standard collected from [REDACTED].

The pistol was sub-designated into swabs from the grip (D1), the trigger area (D2), the front and back sights (D3), and the magazine (D4). The swabs from the grip (D1) showed a low level three person mixture, at least one male contributor but the mixture was not suitable for comparisons due to the complexity of the mixture/limited amount of genetic information available. The swabs from the trigger area (D2), showed a four person mixture, at least two male contributors, but the mixture was not suitable for comparisons due to the complexity of the mixture/limited amount of genetic information available. The swabs from the front and back sights (D3) showed a partial low-level two person mixture and that the mixture was not suitable for comparison due to the complexity of the mixture/limited amount of genetic information available. The swabs from the magazine (D4) showed a four person mixture, at least two male contributors but a major male contributor was [REDACTED]. The minor component was not suitable for comparisons due to the complexity of the mixture/limited amount of genetic information available. All swabs taken were not eligible for entry into CODIS. The Confidential Report of Laboratory Findings will be attached to the case file. For further information regarding this document see the attached form.
