**SUMMARY**

Sunday, 07/05/20

On the above date, City of Waukesha Police Officers had investigated a domestic violence situation that occurred at [REDACTED] in Waukesha. The wife of the suspect went to the police station to report the incident, arriving with her children and and juvenile nephew. While officers attempting contact with the husband at the residence, he shot at police and six officers returned fire. Hours after the initial gunfire, the male suspect was found deceased in the home, from a self inflicted gunshot.

On Monday, 07/06/20, at 3:30AM, the Milwaukee Area Investigative Team responded for an officer-involved shooting at this location, with the Greenfield Police Department being the lead investigating agency.

### SUMMARY OF INCIDENT

On Monday, 07/05/20, at 8:19PM, City of Waukesha citizen [REDACTED] responded to the Waukesha Police Department to report a domestic violence incident. She stated she just fled her residence at [REDACTED] after being assaulted by her husband, [REDACTED]. They have two juvenile sons in common, who responded with her to the police department as well as a six month old nephew. [REDACTED] reported she had just been strangled by [REDACTED]. He had been throwing things in the house, choked her, pushed her against the wall and struck her with his fist. He grabbed a handgun and threatened to kill the family and himself. She informed officers, [REDACTED] seemed to be going through a mental episode. He's stated many times in the past, if the police come to arrest him, he would shoot the police and then himself.

The Waukesha Police Department had been in contact with [REDACTED] twice in 2019. On 04/29/19 at 9:08AM, they were contacted by his mother, who stated [REDACTED] wanted to commit suicide and was off of his medication. He left driving a grey minivan. [REDACTED] was located by Delafield Police Officers. He stated he was not suicidal and was uncooperative with officers. [REDACTED] came back to his residence; however, would not cooperate with police. He went into his residence and slammed the door.

On 09/26/19 at 11:24AM, [REDACTED] mother [REDACTED] called, stating her son had not eaten in three days and was making suicidal statements. The mother said she did not want the police to respond, because the last time they were there it did not go well. She only wanted an ambulance. Upon arrival, [REDACTED] locked himself in the bathroom. He was argumentative and there was not enough to

conduct an emergency detention.

On 07/05/20, during the initial domestic violence investigation with [REDACTED], she informed officers her husband was armed with a handgun but owned several others. The residence was a duplex, however, the only one home was [REDACTED] Waukesha Police Department did a tactical response utilizing an armored humvee containing several uniformed officers. They also had several perimeter officers, a designated marksman unit and New Berlin Police [REDACTED] deployed. Officers first attempted phone contact with [REDACTED] but there was no answer. By 9:58PM, numerous announcements had been made over a PA to [REDACTED] at the above address, while the squad emergency lights were activated. There was no response.

At 10:15PM, less than lethal rounds were fired at the front door and upper exterior walls. At 10:16PM, more announcements were made by officers. At 10:25PM, [REDACTED] shot several rounds from an upper bedroom window. One round fired by [REDACTED] impacted the driver's side windshield of the armored humvee that officers were utilizing. Shrapnel from this round struck one of the officers. Another round struck the ground in front of [REDACTED] and the [REDACTED]. Officers heard gun shots, saw bullet holes in the window glass and muzzle flashes from an upper left window. There were thirteen officers on scene and six returned fire after the suspect shot. After an exchange of gunfire, no contact with the suspect was exchanged.

At 11:33PM, officers utilized an armored vehicle and ram, creating tactical damage in order to deploy surveillance detection equipment. A mobile camera was used to locate [REDACTED] who was slumped over in the bathroom tub with an apparent self-inflicted shotgun wound to his head. In the bathtub with [REDACTED] was a 12 gauge shotgun and a 9mm pistol.

The 9mm pistol was consistent with the round which struck the humvee prior to them exchanging gunfire with him. Ten fired 9mm casings were located in the upper floor of [REDACTED] residence. The shotgun was consistent with the cause/manner of suicide death ruled by the Medical Examiner. [REDACTED] sustained a single self inflicted contact wound which traveled under the chin, upward through the cranial cavity.

Officers stated that the suspect shot numerous times from an elevated window at officers in the humvee, after which they returned fire at the suspect.

According to [REDACTED] wife and parents, he has struggled for years with depression, being bipolar and having ADHD. In 2019, the Waukesha Police had two separate incidents with [REDACTED] regarding mental health related issues. In 2015, after working as a teacher for 16 years, the principal called because [REDACTED] made suicidal statements while working at the elementary school. He mentioned was going to put a gun to his head. When police spoke to [REDACTED] he

said he was diagnosed as bipolar with ADHD. He also mentioned he admitted himself to Aurora Psychiatric a year prior for depression [REDACTED] also told police, at that time, he owned a 9mm handgun.

<p><b>SUMMARY</b></p> <p>Monday July 6, 2020 3:57am</p> <p>On the above date and time, I was notified through text message as well as a missed phone call by Greenfield Police Detective Captain Chuck Fletcher that I was needed for a M.A.I.T. (Milwaukee Area Investigative Team) call out related to an officer involved shooting in the City of Waukesha. We were informed that the briefing location was at the City of Waukesha Police Department. Our agency was the lead investigative team for this incident.</p> <p>I arrived at the City of Waukesha Police Department at approximately 5:00am and met with other Investigators in a conference room. The following information was provided to the M.A.I.T members:</p> <p>The incident started as a call to Waukesha Police Department at 8:19pm for a report of a domestic incident at [REDACTED]. A female resident of that location drove to the Waukesha Police Department parking lot with her children. The female report her husband had grabbed her by her neck and threatened to kill her family and police. The female was able to get her children out of the residence but reported to police her husband was still at the residence and suicidal.</p> <p>Upon Waukesha Police arrival, there was an attempt made to communicate with the male subject inside by making announcements for his surrender. At some point the male subject told Waukesha police that if any officers come inside he would shoot them. The male suspect subsequently fired a rounds at the police officers, striking the windshield of an occupied Waukesha Police rescue vehicle. After an exchange of gunfire, Waukesha Police subsequently located the male subject deceased inside the residence.</p> <p>After the briefing, Captain Fletcher assigned me to gather a team of detectives for a canvas of the neighborhood. Initially the following detectives were assigned to assist with the canvas: Detective Brian Zalewski (Franklin Police Department), Detective Sergeant Jeremy Fadness (Franklin Police Department), Lieutenant Todd Clementi (West Allis Police Department, and Detective Mike Sitter (West Allis Police Department).</p> <p>After we began our canvassing and realized there were more witnesses to talk with, additional detectives arrived to help. These were Detective Sergeant Shane Wrucke (Wauwatosa Police Department), Detective James Donovan (Wauwatosa Police Department), and Detective Paula Roberson (Wauwatosa Police Department). See individual supplement reports from each detective as to their respective interviews during the canvas.</p>

The following are the witnesses I spoke with and their statements:

Shortly after arriving in the crime scene, I made contact with a resident standing next to her red Toyota Camry with Wisconsin registration plate ██████████. The vehicle was parked in the driveway at ██████████. This person was identified as ██████████.

██████████ explained that she lives at ██████████ a short distance of where her car was parked. ██████████ explained that last night around 9pm, she went to the Kwik Trip gas station a short distance away and upon returning, the police had the roads blocked off. The police told her to park the vehicle in the driveway at ██████████ for the time being.

I asked ██████████ what she had seen last night. ██████████ explained that when she left for the gas station there was no police presence in the neighborhood however upon returning while traveling south on Pebble Valley Rd, there was a large police presence blocking the road near Queens Qt. ██████████ said her niece who resides with her, has a police scanner and learned from her the original call to the residence on Pebble Valley Rd was a domestic incident. As the police arrived several neighbors began gathering outside to watch what was going on.

██████████ said that she estimated there were at least 10 officers at the scene but more kept arriving. ██████████ said it appeared to be a SWAT Team. ██████████ said she could see the vehicles had flood lights towards the house and heard announcements by police stating something to the effect of "Waukesha Police, Come out with your hands up, you're under arrest". I asked ██████████ if there would be any doubt it was the police outside the home and she said there would not be any doubt.

██████████ then hear the gunfire. ██████████ had a video on her phone through a Snapchat App which showed a time of 10:26pm when the gunfire occurred. The video did not show anything as it was too dark and too far away however the video did record the sound of many rounds of gunfire in the distance. ██████████ said she was unsure how to forward that video to me but would look at trying to figure it out after work. I later learned that Detective Brian Zalewski talked with another witness who also used Snapchat to record during the incident. That video was forwarded to police for the investigation.

██████████ said that after the gunfire it was quiet after that with numerous other police vehicles arriving in the area. ██████████ estimated that she went back inside her home around midnight and didn't have any more information. ██████████ drove her vehicle from the scene.

I spoke with the resident at [REDACTED]. who came outside as I was talking to [REDACTED]. This person was identified as [REDACTED].

[REDACTED] stated his sister lives in the duplex next door to him at [REDACTED] and learned from her there was a lot of police officers outside. [REDACTED] duplex is only a couple doors down to the south of where this incident took place and inside of the initial perimeter set up by police. [REDACTED] said he observed police with the armored vehicle near the curb facing the house trying to negotiate with the person inside the home. I clarified this was the smaller rescue vehicle which had been since moved to the road when it was replaced by the larger SWAT vehicle.

[REDACTED] said that he heard an officer say "was that a gun shot?" And then thought another officer say "Yeah it was". [REDACTED] said he heard the glass break on the rescue vehicle and saw the windshield had been shot. SIROVINA then said he heard about 15-20 seconds of gunfire from police. Once the gunfire stopped, he said he then heard a single shot. [REDACTED] further said he suspected this was the person inside "taking the pussy way out" which he interpreted as him shooting himself. [REDACTED] said after that occurred, it was quiet. After that officers moved around several squads and SWAT vehicles and then went inside. [REDACTED] told me that he had not been to sleep since this occurred.

In the attached duplex of [REDACTED] at [REDACTED], I spoke with his sister identified as [REDACTED] and her boyfriend [REDACTED]

[REDACTED] outside last evening when this first started putting out party favors in the yard. Police began to show up and blocking off Pebble Valley Rd near her home. Officers were then heard using the PA system on the vehicle to make announcements. [REDACTED] and [REDACTED] at this time were inside their garage with the door open a little so they were able to hear what was happening.

[REDACTED] and [REDACTED] said that they hear a first gun shot and believed it was the suspect shooting at police because she heard an officer say "Was that a bullet?" and then heard another officer reply that it was. Very shortly after that there was over 100 rounds fired by police into the home and described by her as "very intense". [REDACTED] also heard a single gun shot shortly after the large amount of police gun fire.

and recorded some of the events on her phone. Franklin Police Detective Brian Zalewski obtained a statement from [REDACTED] and recovered the video she took during the incident.

I made contact at [REDACTED] which is directly next door to the south of the shooting scene. There I made contact with the residents there [REDACTED] and her husband [REDACTED]

The [REDACTED] explained that they were both home last evening and were watching some TV. [REDACTED] said he heard what he thought was some loud fireworks in rapid bursts. Due to the Fourth of July holiday he didn't think too much about it. [REDACTED] mother lives in the adjoining duplex and let them know that there were a lot of police outside. The [REDACTED] did not see anything further.

I noticed there was an exterior camera mounted on the garage facing towards the driveway and road. I asked [REDACTED] about any footage that camera would have captured. [REDACTED] said that he does not subscribe to the service plan to record and he only has footage going back a couple hours so the incident would not be available.

I asked if they knew the neighbor where this occurred. The [REDACTED] said that their children play with the children at that residence often however were not very social with the parents.

I made contact at [REDACTED] and spoke with [REDACTED] and his wife [REDACTED]. [REDACTED] stated that his wife worked third shift and just recently arrived home and was not at home during this incident. [REDACTED] said that around 9pm a police officer knocked on his door and told him to go to the basement so he did so. [REDACTED] said he was down in the basement for about an hour and then came back up at which time he noticed the large truck with the ram on the front at the house but then went back downstairs. [REDACTED] said he didn't see much of anything and never heard any gunfire. [REDACTED] said that he eventually came back up stairs and went to bed.

amount of police outside and he then met with other neighbors outside to see what was going on. [REDACTED] said that he along with other neighbors were standing in the median of Queen's Ct and estimated there to be 15 to 20 police vehicles already there when he came out. [REDACTED] said that it was dark and couldn't see much.

[REDACTED] said the Humvee type rescue vehicle was parked by the curb facing the house with officers making announcement using the loud speaker. [REDACTED] thought they gave warnings to the person in the house 15 to 20 times. [REDACTED] remembers hearing a single shot that he believed to be from the person inside the home toward the officers. [REDACTED] then heard a large barrage of gunfire from police and estimated 30-40 rounds fired. [REDACTED] said that he watched for a while longer and then went back home and to bed.

## SUMMARY

Monday, 07/06/20, 3:29AM

On the above date and time, I received a text message from Captain Lindstrom, advising that the Waukesha Police Department had an OIS involving a SWAT stand off, and that a call out would be coming out shortly. Captain Lindstrom advised via text message that this incident occurred at [REDACTED], City and County of Waukesha. Captain Fletcher then asked Greenfield Detectives to meet at the Waukesha Police Department.

I arrived at the Waukesha Police Department, where a command post was set up. A briefing then ensued as to the circumstances surrounding this incident. The decedent in this incident was identified as [REDACTED]. During this briefing, it was explained that the initial investigation into this incident showed that [REDACTED] had apparently committed suicide after shooting at Waukesha Police Officers who had responded to his residence for a domestic violence incident. [REDACTED] was alleged to have brandished a handgun and threatened to kill his family during the aforementioned Domestic Violence incident.

After the briefing had occurred, Captains Fletcher and Lindstrom then assigned Greenfield Detectives to this case, as the Greenfield Police Department was the lead investigative agency for the MAIT team. Captain Fletcher informed me that I would be responsible for coordinating involved officers and witness officers.

I then met with Wauwatosa Police Detective James Donovan and Lt. Shane Wrucke and Greendale Police Detective Julie Barth, who were then assigned to interview witness officers. The following Waukesha Police Department witness officers were interviewed at the Waukesha Police Department:

Wauwatosa Police Detective Paula Roberson has been assigned to interview Waukesha Police Officer [REDACTED], Waukesha Police [REDACTED] [REDACTED] and New Berlin Police Officer [REDACTED].

West Allis Police Detective Dave Madden has been assigned to interview Waukesha Police Officer [REDACTED], Waukesha Police Officer [REDACTED] [REDACTED] and Waukesha Police [REDACTED] [REDACTED].

Waukesha Police Specialist Nichelle Nelson photographed the involved officers. Police Specialist Nelson subsequently took custody of all of the firearms that had been discharged in this incident. Police Specialist Nelson informed me that she has maintained a continuous chain of custody of these firearms. Police Specialist Nelson informed me that she also photographed officers' handguns as well, but round counts were not conducted as they did not fire their handguns.

Brown Deer Investigators Brian Guenette and Joshua Morgan were assigned to assist with photographing and packaging the firearms used in this incident as well as conducting round counts. See their attached supplements for details.

Wauwatosa Police Lieutenant Wrucke and Detectives Donovan and Roberson cleared from the Waukesha Police Department and assisted Greenfield Police Detective Brian Wallander in canvassing the area, as numerous potential witnesses were now being located.

After Investigators Guenette and Morgan had finished packaging the firearms and other miscellaneous items and securing them with evidence tape, they were then turned over into my custody. I conveyed those items back to the Greenfield Police Department and placed them inside a secured property room, where they would be inventoried into property as evidence Greenfield Detective Lucas.

I then met with WPPA Staff Attorney Roger Palek and WPPA Representative Jim Schumitsch. It was then determined that interviews of officers represented by the WPPA would be conducted later this week.

Waukesha Police [REDACTED] [REDACTED] indicated he is retaining a private attorney, Michael Steinle, and New Berlin Police [REDACTED] [REDACTED] indicated he is tentatively retaining the legal services of Attorney Michael Steinle. All involved officers were provided with business cards and were told

to contact their respective interviewing detectives for the initial interviews.

On Monday 07/06/2020, Brown Deep Police Investigator Brian Guenette dropped off at our department a flash drive which contained photographs of the involved officers, their weapons and rounds. See photographs attached to this case file.

On Tuesday 07/07/2020, I received an email from Waukesha Police Specialist Nichelle Nelson. Specialist Nelson informed that that Officer [REDACTED] was found to have deployed a less than lethal shotgun round to the rear residence. Specialist Nelson photographed Officer [REDACTED] the shotgun, his handgun and the rifle he had. The less lethal shotgun is in the Waukesha Police Department property room. Specialist Nelson will also provide the paperwork with round counts with the photo DVD.

Oak Creek Detective Robert Michalski was assigned to interview the following Waukesha Police Officers, who covered the rear of the residence during this incident, and had been released from duty prior to the M.A.I.T. Team's arrival.

On Tuesday 07/07/2020, Detective Michalski informed me via email that interviews of the aforementioned three officers and been completed.

On Tuesday 07/0/2020, I responded to the Waukesha Police Department and picked up the round count paperwork for involved Officer [REDACTED] along with a DVD containing photographs. I reviewed the paperwork and confirmed that [REDACTED] had deployed one round from a less than lethal weapon identified as a Remington 870 12gauge less lethal shotgun, serial number CC73587G.

Specialist Nelson also completed round count paperwork for [REDACTED] [REDACTED] sidearm which was identified as a Glock 17, model Gen 4, 9mm, s/n BACK073 with a tactical flashlight identified as a Surefire X300 ultra light. The firearm was listed as not being discharged with three total magazines with capacities of 17,21,21. The report indicated that there was one round in the chamber. The magazine in the weapon contained 17 rounds plus one in the chamber and two additional magazines with 21 each.

Interviews were subsequently conducted of all involved Officers with their respective attorney's. Those reports will be attached to this complaint.

<p><b>SUMMARY</b></p> <p>Monday 07/06/2020 3:47am</p> <p>On the above date and time I received a call from Detective Captain Fletcher reference a M.A.I.T. call up for a City of Waukesha OIS investigation.</p> <p>After first responding to our department to obtain work related equipment I responded to the Waukesha Police Department.</p> <p>Upon my arrival we were briefed on the incident.</p> <p>Detective Captain Fletcher then requested I along with another officer make the notification to the parents and wife of the suspect/deceased. I was also asked to obtain statements from them. I was told they were currently at the Waukesha Police Department.</p> <p>I met with West Allis Police Detective Allison Cerqua who was asked to assist me with the interviews</p> <p>Detective Cerqua and I first met with the parents identified as [REDACTED] [REDACTED]</p> <p>At approximately 5:25am I advised them their son, [REDACTED] was deceased. I further explained our involvement in the incident. We were advised they owned the duplex where this incident took place. They reside at [REDACTED] and [REDACTED] his wife [REDACTED] and their children resided in the other half at [REDACTED]. It should be noted at the time of the incident [REDACTED] and [REDACTED] were at their Cabin in the Minocqua, WI area.</p> <p>I asked if Detective Cerqua and I could speak with each of them separately. They agreed to speak with us, but wanted to remain together. We then spoke with them in an attempt to learn more about [REDACTED] and his actions. See Detective Cerqua's report for a summary of the conversation.</p> <p>We next spoke with [REDACTED] wife, [REDACTED]. At approximately 6:25am I advised [REDACTED] that her husband [REDACTED] was deceased. The following is a summary of the interview. she said he took Alprazolam. She said he also took medication for Asthma, high blood pressure and cholesterol but did not know the names of them. She said a long time ago she read in his diary that he did not want to live.

She said about 3 or 4 months ago he was in bed for about 2 weeks and would not eat or drink. He told her he just wanted to die. She said she asked her boss at work to try and help. She says when he came over [REDACTED] showed her boss a rope and told him he was going to hang himself. She said he also locked himself in the bathroom and took the screen out and threatened to jump. He further told her if she called the police he would shoot them and himself.

I asked if he owned any guns. She said he had a hunting gun and a belt buckle derringer gun that he wore all the time. She also said he had a switchblade knife.

When asked about specific mental health diagnoses she said [REDACTED] was Bi-polar, had depression and anxiety. She did not believe he was taking his medications as directed. She said he would talk/wonder about how long he could go without food or water before you would die. She said he also had a drinking problem as well, but believed he had not drank for the last two years. [REDACTED] parents had advised us about [REDACTED] having been a problem user of many different street drugs years ago. [REDACTED] was asked about this. She was unaware of this and it appears this occurred before they met.

She advised prior to this incident [REDACTED] had never been physically abusive to her or the children. They have two children, [REDACTED] and [REDACTED]. At the time of this incident she was also caring for her 6 month old nephew, [REDACTED]

We then asked [REDACTED] about what occurred prior to and leading up to this incident. She said [REDACTED] had been in bed or up in the bedroom since around noon. She said she made dinner and she and the children ate, but [REDACTED] did not. She said her and the children then went outside and played. She said after they had been outside she got the kids bathed and ready for bed. She said she was then going to take a shower and asked the boys to watch the baby. Around this time she states [REDACTED] got up and was acting strange and staring at the boys. She tried to make light of it and was saying something to the effect about [REDACTED] playing a monster.

She stated he then gets angry and tells her to take her mother's ashes and get out of the house. She stated [REDACTED] grabbed her by the neck and pinned her up against a bathroom door. She said it was hard for her to breath. While he had her pinned against the door he also hit her in the back of her back/side of her head. She said she asked him to stop and let her go and eventually he did. She said she was then trying to gather some belongings up so they could leave.

Captain Fletcher advised that he needed me to respond to the Waukesha Police Department and later to the scene as the Greenfield Police Department was assigned as the lead investigative agency as a part of the M.A.I.T. team.</p> <p>Once I arrived at the Waukesha Police Department, I met with Captain Fletcher and Captain Lindstrom where we were provided with the information regarding the incident and that I was assigned to assist and oversee the crime scene. I was informed that on 07/05/2020 at 8:19PM, a female, later identified as [REDACTED], was in the parking lot of the Waukesha Police Department in a black Toyota and had called 911 to report a domestic violence incident that just occurred at her house, located at [REDACTED], after being assaulted by her husband, identified as [REDACTED] and that the male is still at the house and that [REDACTED] stated [REDACTED] grabbed her by her neck, choked her, struck her with his fist, pushed her against the wall and that he had grabbed a handgun and threatened to kill the family, the police, and himself. Investigators were advised that [REDACTED] was involved in prior calls for service regarding [REDACTED] having suicidal tendencies. On 07/05/20 the Waukesha Police Department responded to the scene in an armored humvee containing several uniformed officers. With Officers on scene, five separate announcements were made over a PA to [REDACTED] [REDACTED] answered back saying if any officers came in he would shoot them and himself. Less lethal rounds were fired at the front door. At 10:25PM, [REDACTED] fired several rounds from an upper bedroom window where one of the rounds fired struck the driver side windshield of the humvee. After [REDACTED] had fired rounds at officers, six officers returned fire. After no further contact was made with the suspect, an armored vehicle and ram was used to breach the upper window and front door. A robot with camera was deployed and had located [REDACTED] in the upstairs bathroom tub with an apparent self-inflicted gunshot wound to his face. responded briefly to the scene. Photographs of the roadway, exterior, and interior of the home were photographed by the Crime Lab Response Team before any items was manipulated or collected.

Once the scene was documented and the scene was scanned using the FARO instrument, I was advised that the Waukesha County Medical Examiner could be contacted for them to come to the scene. A short time later, I was met by Deputy Medical Examiner KRISTINE M. KLENZ who was shown where the deceased was located. After the medical examiner staff had taken overall photographs, [REDACTED] was removed from the bathtub and photographed again. [REDACTED] was removed from the bathroom and placed into the hallway in order to place him into a transport bag. Before [REDACTED] hands were bagged. A FAST ID machine was used to confirm [REDACTED] identity. I also searched [REDACTED] short pockets. In the right front pocket, I located a black TCL cellphone that did not appear to be on. In the left front pocket was a pistol magazine containing seven 9mm bullets. It should be noted that 10 fired 9MM cartridge casings were located in the up stairs area of the home. The cellphone was placed into a paper bag by me and was then provided to Crime Lab Staff. It should be noted that I had also located an Iphone on the dresser located in the front bedroom. This phone appeared to be on and I placed it into airplane mode. This cellphone was later collected by me. I also provided Crime Lab Staff members with the pistol magazine. After [REDACTED] person was searched, KLENZ bagged his hands at 2:56PM. After [REDACTED] hands were bagged, the body bag was sealed using tag #0003491 and then the body was removed from the home. I was also provided with Waukesha County Medical Examiner's Case #20-1471 and that the time of death was pronounced at 4:48AM. I was later contacted by the Waukesha County Medical Examiner's Office and I was advised that the autopsy would be completed at 12:00PM on 07/07/2020. After the body was removed, evidence documented and recovered by the Wisconsin State Crime Lab, I was provided with all of the collected evidence by LISA TREFFINGER. I was a/so provided with several handwritten Receipts of Physical Evidence Form that assigned a Wisconsin State Crime Lab Case #R20-1913. This form was also signed by TREFFINGER and I. All evidence was later transported to the Greenfield Police Department where it was inventoried and placed into a property locker. The signed copy of the Receipts of Physical Evidence will be attached to the case file. The entered property was attached to the end of this report. Once the evidence was collected, I turned the crime scene back over to the Waukesha Police Department at 5:30PM.

On 07/07/2020, I responded to the Waukesha County Medical Examiner's Office for the autopsy of [REDACTED]. I was also advised the day prior that the medical examiner would like to see the weapons collected from the scene to compare them with the body. The autopsy was performed by Dr. LYNDIA BIEDRZYCKI. As the autopsy began, I could see that the decedent's hands were still bagged. There were multiple clothing items still on. The clothing items were removed by Dr. BIEDRZYCKI and placed onto a table so they could be photographed. Once the photographs were taken and the clothing items documented, I was advised that I could collect them. I collected a pair of tan

shorts, blue pair of underwear, a red and orange wrist band, and a leather necklace with a green stone affixed to it. Each clothing item was packaged separately into paper bags. These items were later taken back to the Greenfield Police Department where they were inventoried and placed into a property locker. I was advised by Dr. BIEDRZYCKI that an xray was completed on the deceased and that there may potentially be a metal object inside of the [REDACTED] head. It should also be noted that Dr. BIEDRZYCKI requested I cut open a shotgun shell recovered from the scene to compare the shot within the shell to what was going to be collected from [REDACTED] skull interior. I cut open a Federal Premium #4 1-1/4oz and a 00Buck shot shotgun shell. This was photographed by BIEDRZYCKI and was later repackaged with the shotgun. On 07/10/20, I received a Preliminary Autopsy Findings from the Waukesha County Medical Examiner's Office. The form states:

## 1. Shotgun wound to the head

## A. Contact shotgun wound to head

1. Muzzle imprint under chin
2. Soot and filler along wound track

B. One large size gilded pellet recovered from cranial cavity and retained

## C. Extensive craniocerebral disruption as a result of the shot

D. Direction of wound track upward when the body is in the anatomical position

X-rays do not reveal any further retained pellets. Presumptive postmortem urine drug screen positive for THC, benzodiazepines and amphetamines.

Dr. BIEDRZYCKI later ruled the cause of death as shotgun wound to head and that manner of death as a suicide. I was provided with a DNA card as well as the above mentioned clothing. I was also provided with a DVD containing scene photos taken by Medical Examiner Staff that responded to the scene and the x-rays taken. A copy of the signed property sheet will be attached to the case file. The Preliminary Autopsy Findings and the Cause of Death form will be attached to the case file.

On 07/13/2020, I received numerous digital items from the Waukesha Police Department. They consist of scene photos taken by the Waukesha Police Department, radio traffic during the incident, the 911 call from [REDACTED] squad camera footage from [REDACTED]. Also provided was MRAP video. All of these items will be attached to the case file. On 07/15/2020, I was contacted by [REDACTED] who resides at [REDACTED] which is close to the incident scene. I was advised that he had located a bullet in his driveway and did not provide it to the detective that had spoken to him On 07/17/2020. This bullet that appears to be a 9MM bullet was inventoried and
