SUMMARY

Monday, 10/19/20, 1:56PM

On the above date and time, South Milwaukee Police Lieutenant Jason Walker requested the lead investigating agency for the Milwaukee Area Investigative Team, to contact him in regards to an officer involved shooting that just occurred in South Milwaukee. I contacted Lieutenant Walker, who informed me that an officer involved shooting occurred at 725 Blake Avenue in South Milwaukee. A female contacted the police department after receiving a suicidal text from a male friend at that residence. Her friend, JAYSON MARTIN, threatened to shoot himself. When officers arrived at the residence, the suspect was on the porch, armed with a handgun. The suspect shot once at police and one officer returned fire, shooting and killing the suspect.

SUMMARY OF INCIDENT

On Monday, 10/19/20, at 1:23PM, the South Milwaukee Police Department dispatched squads to 725 Blake Avenue, South Milwaukee, after speaking with REBECCA L. KOIER, F/W, 06/22/83. KOIER called regarding a suicidal text she received from a friend, JAYSON E. MARTIN, M/W, 11/13/76, who resides alone at that address.

MARTIN and KOIER had been friends for over six years. They'd been intimate in the past; however, were now more platonic friends in a non-committal relationship. On Monday, 10/19/20, they were talking via text, about refunding airline tickets and at one point he accused her of lying. At 12:53PM, MARTIN's texts to her stated, "I get it. I'm done with it all though. Forget flights... Imma bout to blow my brains out". She immediately responded, "WTF?" At 12:58PM, she tried to reach him and texted, "In exactly 5 minutes I'm calling the cops". At 12:59PM, she texted, "4 minutes". At 1:16PM, she contacted the South Milwaukee Police Department to report the suicidal threat. She informed the dispatcher of his suicidal text and the fact that he owns a firearm. At 1:23PM, squads were dispatched for a welfare check at 725 Blake Avenue.

At 1:27PM, uniformed [REDACTED] both arrived on scene in marked police squads. [REDACTED] parked his squad north of the home, on 8th Avenue. He momentarily walked away but returned, moving his squad to block the intersection at Blake Avenue and 8th Avenue. [REDACTED] then removed his squad rifle and started to walk back toward 725 Blake Avenue but on the north side of the street.

[REDACTED] parked his marked squad facing north, next to 3301 8th Avenue. He parked in a manner where he could see directly east, able to view the front porch at 725 Blake Avenue. [REDACTED] was in police uniform and immediately contacted the caller, KOIER, via phone.

Ms. KOIER received one last text from MARTIN, having a time stamp of 1:29PM. KOIER had previously told MARTIN (12:58PM) that she was going to call the police but received no response. This last text message he sent to her at 1:29PM stated, "Please do.... I'm ready".

Radio traffic indicated officers saw MARTIN on the front porch, talking on his cell phone. He then went into his home, but returned outside holding a semiautomatic handgun.

At approximately 1:34PM, [REDACTED] parked his squad at 8th Avenue and Blake Avenue, took out his squad rifle and started to walk in an easterly direction, across the street from MARTIN's home. At this time, MARTIN was seen exiting his home and [REDACTED] identified MARTIN as having a handgun in his right hand. [REDACTED] took a position behind a large tree at 724 Blake Avenue, which was directly north across the street from MARTIN's residence. Officers continuously told MARTIN to drop the gun but MARTIN sat down in a chair next to the door on the front porch. He was holding the gun and smoking a cigarette.

When uniformed [REDACTED] had arrived on scene, he was positioned directly to the west of MARTIN's home/porch. He was standing at 3301 8th Avenue, using the corner of the home as cover. He could clearly see MARTIN on the porch and stated, "Jayson, I am here to talk." MARTIN then walked into his house. Moments later MARTIN returned to the porch holding a semi-automatic handgun. [REDACTED] and other officers repeatedly told him to drop the gun.

Behind [REDACTED], parked on 8th Avenue, was [REDACTED]. As soon as MARTIN was seen on the porch with the handgun, MARTIN ended his phone call with KOIER. He then took a cover position behind his marked squad. From his position, he could see MARTIN on the front porch with a handgun.

For approximately four and a half minutes, multiple officers tried to negotiate with him. They told MARTIN to put the gun down over twenty times. Officers described him as being in distress and appearing to have been crying. MARTIN is seen putting the gun to his own head but then lowered it.

At approximately 1:39PM, [REDACTED] makes a statement about MARTIN, stating, "He's cocking it". [REDACTED] saw MARTIN put his cigarette in his mouth and racked the slide, chambering a round. Approximately five seconds later, MARTIN then shoots one round. [REDACTED] stated he observed MARTIN shoot in a northwest direction. [REDACTED] immediately returned fire before MARTIN could shoot again. [REDACTED] shot one .223 rifle round from his cover position across the street by the tree, striking MARTIN in the upper left chest.

Officers observed MARTIN slump over but he still had the pistol in his

right hand.

██████████ moved towards the porch from the west, followed by ██████████. ██████████ left the tree and moved toward the front of the porch as well. ██████████ stepped onto the porch and used his foot to slide the handgun away from MARTIN'S hand. ██████████ maintained rear security. ██████████ arrived to assist in securing the scene. Officers requested emergency medical attention and immediately started to render first aid.

Upon approach to the front porch, body cameras clearly show MARTIN slumped over in the chair, still holding onto a black semiautomatic handgun with the hammer locked back. The weapon was examined, having one round chambered with three more live rounds in the magazine. The spent 9mm casing matching that firearm was located at the scene. The casing was found several feet to the north, consistent with MARTIN firing the weapon in a northwesterly direction.

During a canvass of the immediate area several witnesses were located. Witnesses gave statements consistent with the above described events. MARTIN was seen with a handgun, armed/uniformed officers ordered him to drop the firearm repeatedly, MARTIN fired his weapon, ██████████ returned fire and MARTIN was seen slumped over holding his handgun.

MARTIN's son TAYLOR, stated his father has struggled with alcoholism in the past. On October 12, 2020 he went to a football game with his father and his father made several concerning statements, "If anything ever happened to me, don't let your mom in the house." and "No matter what happens to me, know I love you."

An interview with his employer, Griffin Hub Auto, revealed they had fired and re-hired MARTIN numerous times in the past. He had gone to rehab for alcoholism. MARTIN was recently fired again on 10/16/20.

Inside of the home officers located a high volume of empty Fireball whiskey bottles. In the living room, there was a partially drank bottle of whiskey on a shelf. On the recliner was an empty handgun case, his car keys and his cell phone.

The autopsy conducted by the Milwaukee County Medical Examiner's Office indicated the rifle round went through MARTIN from chest to back. It entered the upper left chest, struck the left ventricle of the heart and exited the lower mid-back. The rifle round then struck the house wall behind him. The round was recovered.

Crime lab ballistics analysis confirmed the casing recovered near MARTIN was fired from his handgun. The recovered rifle round recovered from the wall

<p>SUMMARY</p> <p>Monday, 10/19/2020 at 1:57PM,</p> <p>On the above date and time, I was advised that there was an officer involved shooting involving the South Milwaukee Police Department. Captain Fletcher advised that he needed me to respond to the scene as the Greenfield Police Department was assigned as the lead investigative agency as a part of the M.A.I.T. team.</p> <p>Once I arrived at the South Milwaukee Police Department, I met with Captain Fletcher and Captain Lindstrom where we were provided with the information regarding the incident and that I was assigned to assist and oversee the crime scene. I was informed that on 10/19/2020 at 1:23PM, squads from the South Milwaukee Police Department was dispatched to 725 Blake Avenue, South Milwaukee, WI, 53172 after the caller received a suicidal text message from JAYSON E. MARTIN, M/W, DOB: 11/13/1976.</p> <p>The crime scene consisted of the address of 725 Blake Avenue as well as the yard of 3211 8th Avenue as this is where [REDACTED] had discharged the rifle from. The Wisconsin State Crime Lab assisted in processing the scene. The Wisconsin State Crime Lab team members that processed the scene were [REDACTED]</p> <p>[REDACTED] The deceased was located on the front porch area of 725 Blake Avenue with blue tarps that were placed surrounding him. When I arrived on scene the deceased was in a supine position (face up) as it appeared that life saving measures had been performed on MARTIN. Numerous items of medical equipment from the Fire Department was left on scene. These items were returned after the crime scene was photographed and documented by the Wisconsin State Crime Lab and the Milwaukee County Medical Examiner's Office. A 9mm Star pistol was recovered from the scene. This pistol was originally seen in MARTIN's right hand when he was found slumped over in the chair he was seated on. The weapon was then made safe and the firearm contained three bullets in the magazine and one bullet chambered. The firearm serial number was run through dispatch and I was advised that it came back negative for any stolen status. The serial number was SBM201810. [REDACTED] rifle was also transported back to the scene and Detective Birschbach took care of the round count and documentation of this weapon. Once the rifle was documented, the rifle, 27 bullets, and rifle magazine was turned over to me. I placed the packaged rifle into the trunk of my squad car where it was secured. I was later provided with 1 fired cartridge case recovered from grass east side of 3211 8th Avenue, one Star SA Handgun 9mm with magazine, with 3 cartridges and 1 cartridge from chamber, and one fired bullet recovered from exterior wall west side of 725 Blake Avenue. Physical Evidence form by [REDACTED] This form was signed by him and I. The Receipt of Physical Evidence Form assigns Wisconsin State Crime Lab Case #R20-3075. This form will be attached to the case file.

After the crime scene was documented and photographed, I contacted the Milwaukee County Medical Examiner's Office. I spoke to Forensic Investigator DEBBIE STODOLA, who stated that she would be responding to the scene. Upon her arrival, I went over what I had learned and she stated that the Time of Death was going to be 2:16PM. I was also provided with a Milwaukee County Medical Examiner's Office Case #20-7266. After documenting the scene and taking the necessary information DEBBIE bagged MARTIN's hands at 6:04PM. I was also advised that an autopsy would be performed at 8:00AM on 10/20/2020. DEBBIE also contacted a transport team and the deceased was secured in a body bag with lock #226461 and then removed.

After the deceased was removed from the porch area, I assisted the Wisconsin State Crime Lab in looking for the spent shell casing under the porch area as there was enough spacing in between the floor boards for a shell casing to fall through. Wisconsin State Crime Lab personnel dismantled a portion of the porch in an attempt to locate the spent shell casing. It was decided by Chris Johnson and I that the best course of action was to come back to the scene in the morning when there was daylight. The scene was turned over to officers of the South Milwaukee Police Department who were going to remain on scene for security until our return on 10/20/20 at 9:30AM.

A warrant was completed for 725 Blake Avenue, Upper, South Milwaukee, WI, 53172 and a copy of this warrant was later provided to me by Investigator [REDACTED]. The search warrant was executed at 6:50PM by Detective Captain, Fletcher, Detective Hoppe, Detective Wallander, Officer Spodick and I. Photographs of the interior of the home were taken by me before any item was manipulated. Found on the dresser in the bedroom was a box of 9mm Luger 124 grain full metal jacket bullets. This box contained 18 bullets and matched the other bullets found in MARTIN's pistol magazine. Also on the dresser was a baggie of suspected marijuana as well as a mason jar containing suspected marijuana. On the dresser a wooden container containing a marijuana "one hitter" pipe was located. In the jewelry box on the dresser and blue and red marijuana pipe was found. All of these items were collected by me and placed into separate paper bags. In the living room of the home a soft pistol case and a black cell phone were located on the living room armchair. The pistol box for the Star pistol was found on the book shelf on the living room. The cell phone and soft pistol case were collected by Detective Wallander and later turned over to me. I packaged the pistol box into a paper bag. On the living room shelf, A Fireball cinnamon whiskey bottle that was 3/4ths empty was located. 18 empty Fireball cinnamon whiskey bottles were located in the kitchen garbage. These items were only photographed and no collected. All evidence collected was turned over to me where they were secured in my squad car. All collected evidence was transported to the Greenfield Police

Department where it was inventoried and placed into property.

I used an electronic scale to weigh the suspected marijuana. The suspected marijuana in the plastic bag weighed 4.96 grams. The suspected marijuana in the mason jar weighed 6.29 grams. I used a Duquenois-Levine Reagent NARC II test pouch to test each substance. It should be noted that I am trained and certified in the use of this field testing drug pouch. The tests showed the presence of THC. I then used a Hemp/CBD screen test pouch on each substance and was given a high level THC indication. The marijuana was then packaged, inventoried into property and placed into a property locker.

On 10/20/2020 at 9:30AM, The Wisconsin State Crime Lab responded back to the scene in order to locate the fired shell casing from MARTIN's pistol. Detective Hoppe went initially to the scene as I was still at the autopsy of MARTIN. Once the autopsy was completed, I responded to the crime scene to replace Detective Hoppe. Also on scene was Special Agent Kurt Bentley, who is a canine handler with the ATF who has a dog that was trained in gunpowder detection in an attempt to assist in locating the spent shell casing. Chris Johnson removed the rest of the porch floor boards, sifted through the below contents of the porch, and metal detected in the surrounding area with negative results.

I spoke to the homeowner KAYLA J. YUNTO, F/W, DOB: 10/07/89 in order to get consent to the common hallway off of the front porch as the door had been secured after the search warrant was completed the previous night by Greenfield Detectives. I completed a Consent to Search Form with KAYLA to which she provided consent to a search of the common hallway. The consent search form was signed by KAYLA and I. This form will be attached to the case file. I was provided with keys to the front door which I unlocked. Crime Lab Supervisor CHRIS JOHNSON, DNA ANALYST BENJAMIN DESTAERCCKE, and I then searched the common hallway for the missing 9mm shell casing from MARTIN's gun as it was relayed to investigators at the crime scene that upon approach to the home this door had been originally open. The hallway was checked with negative results. The door was re-secured and the keys were provided back to KAYLA. After the search for the shell casing came up with negative results, the crime scene was released at 1:15PM. It should be noted that I was notified by JOHNSON that on 10/20/20 that the missing casing had been found by [REDACTED]. The shell casing was found in the front yard of 725 Blake Avenue and this location was marked by [REDACTED]. The found shell casing matched the loaded shells found in the magazine of the firearm and the box of ammunition located in MARTIN's residence. The found shell casing was turned over to Officer Dziedzic and this shell casing was placed into property.

On 10/21/20, I met with JOHNSON again at the crime scene and the location of the shell casing was photographed and measurements taken. A possible bullet defect was located in the siding of 801 Sherman Avenue was located but this was unconfirmed as I was not able to make any contact with the homeowner. I left

my business card at the home and had not received any call back. The rest of the neighborhood was checked for any other defects with negative results as we were unable to confirm the direction of MARTIN's shot.

On 10/21/2020, I received images, videos, and PDF's generated by the Wisconsin State Crime Lab in a shared folder. These items were downloaded and attached to the case file. I also received a secondary photo of the return to scene after the shell casing was found on 11/02/2020. These items have been downloaded and attached to the case file. This is all of the information I have for this case at this time.

<p>SUMMARY</p> <p>Tuesday 10/19/2020</p> <p>On the above day and date I was assigned to assist on investigating an officer involved shooting which had occurred at 725 Blake Avenue, South Milwaukee in Milwaukee County. I was asked to respond to South Milwaukee Police Department, 2424 15th Ave, South Milwaukee.</p> <p>Once at the police department I was briefed and told this incident involved a subject identified as JAYSON E. MARTIN, M/U, DOB 11/13/76 who had texted a friend identified as REBECCA L. KOIER, M/W, DOB 06/22/83 saying good bye. South Milwaukee Police were then dispatched to MARTIN's residence for a welfare check. Once on scene MARTIN fired a single shot and a South Milwaukee police officer returned a single shot striking MARTIN. MARTIN ultimately was pronounced deceased on scene.</p> <p>I was advised that KOIER was currently at the police department in the front lobby and I was asked to take a statement from her.</p> <p>INTERVIEW OF REBECCA L. KOIER</p> <p>KOIER told me she knew MARTIN through mutual friends and they have been friends for the last 6-7 years. When asked if their relationship was ever intimate KOIER told me it use to be like "Netflix and Chill" but they were never really together and had an on again off again intimate relationship. KOIER said they hadn't had sex since well before COVID and she thought it could have been longer than a year ago since they last had sex. She just considered themselves friends.</p> <p>Recently MARTIN had been upset with her and accused her of lying about being in a relationship with another guy. KOIER said she last saw MARTIN Tuesday afternoon or evening at her house and they hadn't spoken since Saturday. They had a trip planned together for January and were suppose to fly to Arizona. Today she had texted him about getting a refund on the tickets because MARTIN wanted to cancel the trip. said she was later contacted by MARTIN's son, TAYLOR, and told that MARTIN was dead and she came straight to the police department.

KOIER told me MARTIN was a drunk. KOIER had personally taken MARTIN to rehab/detox 4 or 5 times in the past and believed he had gone in for treatment more than that. MARTIN's choice of drink was Fireball Whisky. When MARTIN drinks he "falls off the face of the Earth". I asked if she believed MARTIN was intoxicated at the time of this incident and she told me she believes he was just because she knew he didn't go into work today and based on what happened today KOIER thinks this was extremely out of character for him. [REDACTED] transmits over the radio asking [REDACTED] to head to the back. [REDACTED] makes his way towards a tree just north of this cargo trailer. [REDACTED] then starts walking back to his squad car and asks a citizen to go back inside their house. [REDACTED] tells a nearby officer he is going back to his squad to get a long gun.

[REDACTED] transmits he is going to move his squad car and block 8th/ Blake and he also transmits requesting a squad block traffic at 7th/ Blake. Another officer goes over the radio and advises that a subject was sitting on the front porch and put his hands in his pockets and walked inside. north of the cargo trailer and asks [REDACTED] if he ran the 28. [REDACTED] gets the response "no". It appears that [REDACTED] then runs the silver SUV's plate over the air of AFC8699. Once [REDACTED] is near the tree behind the cargo trailer you can hear him charging the rifle and see him putting the rifle strap over his shoulder. [REDACTED] raises his voice and says in the direction of the house "Jayson why don't you come outside for me?" Immediately [REDACTED] vocalizes to officers nearby that the subject has a gun in his hand (1:34PM). Then [REDACTED] repeats over the radio that he has a gun in his hand.

Other officers are heard talking to dispatch asking for the subject's phone number. An officer is heard asking Jayson what's going on and other officers are heard at least seven more times telling Jayson to put down the gun. [REDACTED] communicates his view is obstructed by a pillar and he can't see the gun. [REDACTED] says again "put it down" [REDACTED] instructs Jayson to put the gun down a total of 12 times throughout this video). Another officer is heard asking Jayson if he has a phone on him and if he can call him. Two more times other officers instruct Jayson to put down the gun.

A blue truck is seen driving westbound down Blake street (1:38:13PM) and [REDACTED] goes over the radio telling officers to shut down 7th street. While [REDACTED] transmits this you can see his rifle is up and rested on the right side of the tree facing the house but [REDACTED] arms go back up obstructing the cameras view after he is done transmitting. Dispatch goes over the air giving out a phone number for Jayson of 803-2233 (1:38:36PM). Officers are heard in the background asking Jayson what's bothering him. Jayson is told by other officers again to put it down at least two more times. (This video shows [REDACTED] and others instructing Jayson to put the gun down at least 23 times total in this video.)

An officer is heard says "we're here to help you". Immediately after this is said a single shot is heard (1:39:07 PM- Jayson firing) followed by a second shot (1:39:08- [REDACTED] firing). Officers are heard yelling drop the gun. Someone transmits that the subject is down.

him what happens and where casings should be on scene. He walks up to the house where someone points to the house and says there's a round in the wall. He's told it's a through and through shot. Paramedics are seen coordinating at the front of the house. [REDACTED] said he could tell the gun fired and cycled and they can't find the casing.

[REDACTED] then goes to where [REDACTED] is standing by the back door and unlocks the door and goes inside. He walks around the lower unit looking for the dogs. He finds them crated in what looks like a back bedroom and let's one out. One runs out into the fenced in yard and he grabs the leashes. He comments the other dog doesn't want to come out so he goes back inside and puts the leash on the dog and takes him outside and turns that dog over to [REDACTED]. He goes back into the unit to turn all the lights off and secures the unit. He goes to the back fence and talks to a woman who was with the dog owner. let's them know there is a women trying to get into her house on the northeast corner just to the west of 725 Blake Avenue. They agree she can go in her home and he walks over to where she was parked in her driveway and let's her know she can go in. Right after he speaks to that resident the male homeowner of 725 Blake comes up to speak to [REDACTED] and he expressed he just cared about the dogs getting out of the house. [REDACTED] lets him know he'll have someone call them when they can access the house again and tells them he's not sure how long that will be. Chris Johnson arrives (2:52PM) and [REDACTED] approaches him. Chris Johnson shows him his Crime Lab work ID and lets him in to the scene. They begin speaking of making a log. Dispatch lets him know that the son is on the phone and the bosses on scene discuss what should be said to him.

[REDACTED] call in to dispatch and gets the son's phone number. [REDACTED] calls the son and asks him how much he knows. He confirms with the son that he was shot and has died and tells him he can come to the police department. [REDACTED] confirms the son has someone with him and tells the son that he can call or come in to the police department for more answers later.

When he's done with the phone call he discusses with Chris Johnson where the gun the suspect had is and tells him that one of the investigators secured it. Two other police officers walk up and they all talk about coordinating who is doing what. He then walks away and his body camera is shut off at 3:06PM.
